EXECUTIVE ORDER CREATING THE  
STATE COUNCIL ON VOCATIONAL EDUCATION  
ALSO KNOWN AS THE  
VOCATIONAL EDUCATION ADVISORY COUNCIL

---

WHEREAS, Section 112 of the Carl D. Perkins Vocational Education Act of 1984 (Pub.L.No. 98-524) requires that each State wishing to participate in the vocational education programs authorized by that Act establish a State Council on Vocational Education; and

WHEREAS, Pub.L.No. 98-524 requires that such council shall be "appointed by the Governor, or, in the case of States in which the members of the State board of education are elected..., by such board"; and

WHEREAS, the State Board of Education in Montana is not an elected body.

NOW, THEREFORE, I, TED SCHWINDEN, GOVERNOR OF THE STATE OF MONTANA, by virtue of the authority vested in me pursuant to Pub.L.No. 98-524, and the Constitution and laws of the State of Montana, specifically Section 2-15-122, MCA, do hereby create the Montana State Council for Vocational Education also known as the Vocational Education Advisory Council ("Council").

I. PURPOSE

The Council shall carry out all duties assigned to it pursuant to Pub.L.No. 98-524 and amendments thereto.

II. COMPOSITION

The Council shall consist of thirteen (13) members who shall serve terms of two (2) years and at the pleasure of the Governor. The names and addresses of the appointees are set forth below:



III. DURATION


Council shall exist for a period of two (2) years from the effective date of this Order unless extended by Executive Order.
