EXECUTIVE ORDER CONTINUING THE STATE COUNCIL ON
VOCATIONAL EDUCATION ALSO KNOWN AS THE
VOCATIONAL EDUCATION ADVISORY COUNCIL

WHEREAS, Section 112 of the Carl D. Perkins Vocational and Applied Technology Education Act of 1990 (Public Law No. 101-392) requires that each state wishing to participate in the vocational education programs authorized by that Act establish a State Council on Vocational Education; and

WHEREAS, P.L. 101-392 requires that such council shall be "appointed by the Governor, or, in the case of States in which the members of the State Board of Education are elected..., by such board"; and

WHEREAS, the State Board of Education in Montana is not an elected body.

NOW, THEREFORE, I, MARC RACICOT, Governor of the State of Montana, by virtue of the authority vested in me pursuant to P.L. 101-392, and the Constitution and the laws of the State of Montana, specifically Section 2-15-122, MCA, do hereby continue the Montana Council on Vocational Education also known as the Vocational Education Advisory Council

1 ("Council").

3 I. PURPOSE

4 The Council shall carry out all duties assigned to it
5 pursuant to P.L. 101-392 and amendments thereto, and such
6 other responsibilities set forth by the Governor from time to
7 time.

8
9 II. COMPOSITION

10 The Council is composed of thirteen (13) members,
11 including seven (7) from the private sector and six (6) from
12 the public sector. Appointment of members must be in
13 compliance with Section 112(a)(1)(2) of Public Law 101-392 and
14 Title 34, Part 403, Subpart B 403.18 of the Code of Federal
15 Regulations. The names and addresses of members who shall
16 serve at the pleasure of the Governor are submitted by
17 separate letter to the Secretary of State, the Board of
18 Regents and the State Board of Public Education.

20 IV. TERMINATION OF PRIOR EXECUTIVE ORDER

21 Any provisions of prior executive orders relating to the
22 members and authority of the Montana Council on Vocational
23 Education are hereby superseded by the provisions of this
24 Order.

1 V. DURATION

2 The Council shall exist until two years from the
3 effective date of this order. This Order shall be effective
4 immediately.
