Executive Order Creating an Aging Advisory Council, otherwise known as the Advisory Council on Aging.

WHEREAS, the Forty-Eighth Legislature passed House Bill 873, (Chapter 664, Laws of Montana, 1983) which was signed by me on April 27, 1983; and

WHEREAS, House Bill 873 requires the Governor to appoint an 11 member Advisory Council on Aging.

NOW, THEREFORE, I, TED SCHWINDEN, Governor of the State of Montana, by virtue of the authority vested in me under the laws and Constitution of the State of Montana, and specifically pursuant to House Bill 873, do hereby create the Aging Advisory Council, otherwise known as the Advisory Council on Aging.



II. PURPOSE

The purpose of the Advisory Council on Aging is to act as the advisory board to the Coordinator on Aging.


III. DURATION


