EXECUTIVE ORDER CONTINUING THE EXISTENCE OF THE
AGING ADVISORY COUNCIL, OTHERWISE KNOWN AS THE
ADVISORY COUNCIL ON AGING

WHEREAS, section 2-15-231 creates an Advisory Council on Aging; and
WHEREAS, 2-5-231, MCA, requires the Governor to appoint 11 persons
to this council; and

WHEREAS, Senate Bill 311, (Chapter 171, Laws of Montana, 1985),
requires the Governor to stagger his initial appointments to this Council.

NOW, THEREFORE, I, TED SCHWINDEN, Governor of the State of
Montana by virtue of the authority vested in me under the laws and Constitution
of the State of Montana, and specifically pursuant to sections 2-15-231 and
2-15-122, do hereby appoint the members of the Aging Advisory Council,
otherwise known as the Advisory Council on Aging.

Pursuant to S. 2-15-231, the purpose of the Advisory Council on Aging is to act as the advisory board to the Coordinator on Aging.


III. DURATION
