Executive Order creating the REFUGEE ADVISORY COUNCIL and waiving the residency requirements for certain Council members.

I, THOMAS L. JUDGE, Governor of the State of Montana, pursuant to the authority vested in me by Section 2-15-122, MCA and 45 CFR 400.9, do hereby create the Refugee Advisory Council, within the Department of Social and Rehabilitation Services.

The purpose of the Council shall be to assist in the development and review of any amendments to the State Refugee Plan after January 1, 1981, prior to the submittal of a plan amendment to the Office of Refugee Resettlement.

The Council shall be composed of no less than five and no more than twenty-five members who live in the State and who are refugees eligible to benefit from services under the plan by virtue of being a refugee; and representatives of local government, voluntary resettlement organizations, service providers and other interested organizations and individuals.




