Executive Order No. 15-89

Executive Order designating the Child Support Enforcement Division of the Department of Social and Rehabilitation Services as a criminal justice agency pursuant to the Montana Criminal Justice Information Act of 1979.

I, Stan Stephens, in accordance with the authority vested in me as Governor by the laws and Constitution of the State of Montana, and pursuant to the Montana Criminal Justice Information Act of 1979 (Title 44, Chapter 5, MCA), do hereby designate the Child Support Enforcement Division of the Department of Social and Rehabilitation Services, as a "criminal justice agency".
