Executive Order No. 16-93

EXECUTIVE ORDER DESIGNATING THE MONTANA BOARD
OF HEALTH AND ENVIRONMENTAL SCIENCES AS THE
STATEWIDE HEALTH COORDINATING COUNCIL

12 WHEREAS, Section 50-5-304, MCA, incorporates the State
13 Health Plan as an integral part of certificate of need review
14 pursuant to Title 50, Chapter 3, MCA; and

15 WHEREAS, Section 50-5-101(42), MCA, states that the State
16 Health Plan, by definition, is prepared by the Department of
17 Health and Environmental Sciences to project the need for
18 health care facilities within Montana, and is approved by the
19 Statewide Health Coordinating Council and the Governor; and

20 WHEREAS, state law does not specify a method for the
21 appointment of the Statewide Health Coordinating Council; and

22 WHEREAS, the Montana Board of Health and Environmental
23 Sciences has statutory responsibilities concerning matters of
24 public health.

25 NOW, THEREFORE, I, MARC RACICOT, Governor of the State of
26 Montana, by virtue of the authority vested in me by
27 Constitution and the laws of the State of Montana, do hereby

1 appoint the Montana Board of Health and Environmental Sciences
2 to act as the Statewide Health Coordinating Council.

3 I. PURPOSE AND SCOPE

4 The Montana Statewide Health Coordinating Council shall
5 review and approve or disapprove the State Health Plan and any
6 updated portions thereof presented to it by the Department of
7 Health and Environmental Sciences for the purpose of
8 projecting the need for health care facilities within Montana.

9 II. COMPOSITION

10 The Statewide Health Coordinating Council is composed of
11 the members of the Board of Health and Environmental Sciences.
12 Any change in appointment of members of the Board of Health
13 and Environmental Sciences will result in a corresponding
14 change in the Statewide Health Coordinating Council. All
15 members shall serve at the pleasure of the Governor. The
16 Chairman of the Board of Health and Environmental Sciences
17 shall serve as the Chairman of the Statewide Health
18 Coordinating Council.

19 III. DURATION

20 This action to designate the Board of Health and
21 Environmental Sciences as the Statewide Health Coordinating
22 Council will remain in effect unless rescinded by subsequent
23 Executive Order.

24 This Order is effective immediately.
