The sequence identified below is **tentative** and **subject to change**, but our primary goal and focus is the full statewide implementation of FCE.

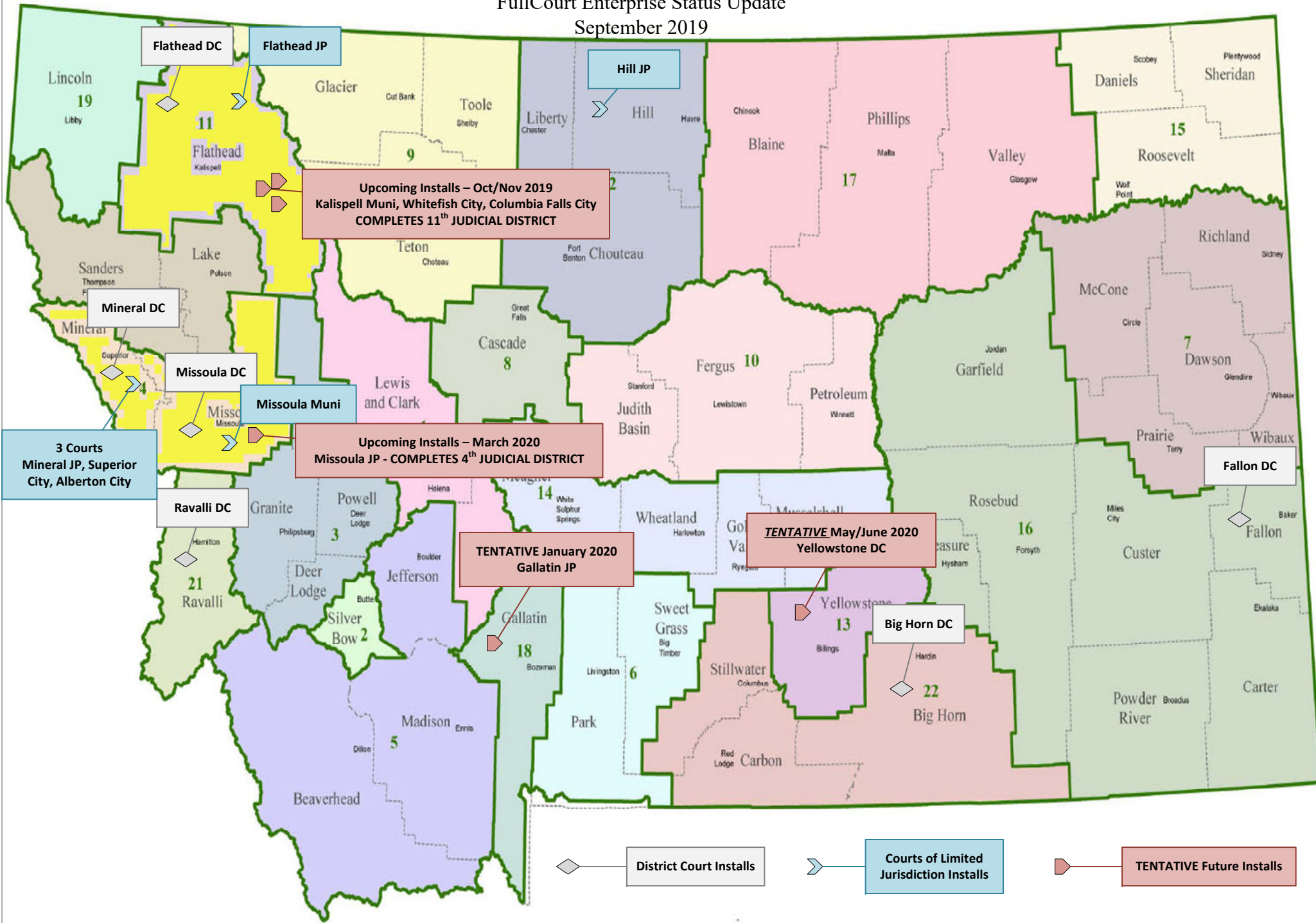
