JUDICIARY COMMITTEE

January 10, 1977

The fourth meeting of the House Judiciary Committee was held in Room 436 of the Capitol Building on Monday, January 10, 1977 at 8:00 a.m. Chairman Scully presided. All members were present.

> Scheduled for hearing were House Joint Resolutions #2 and 3.

JOHN VINCENT:

Sponsor - District #78 When the interim committee took this on, they found they did not have the information necessary. The members of the committee spent hours looking into it to justify the action they took. The case loads, time spent, etc.

REPRESENTATIVE TEAGUE: Why was the number of case loads important?

REPRESENTATIVE VINCENT: We tried to tell how busy a court is, and this would lead us in that direction. did not have any statistical data to see if the requests were justified.

> Several comments were made about reports, court records, etc.

The sponsor closed with the comment, "In order to make a rational judgment, we had to convene to appoint a special committee."

Hearing closed on House Joint Resolution #2.

Hearing opened on House Joint Resolution #3.

JOHN VINCENT: This bill deals with a request that the use of law clerk and secretarial assistance be investigated before creating additional judgeships. Rather than ask for a new district or a new judge, you should look into less expensive and less sweeping suggestions, before you start redistricting lines.

REPRESENTATIVE COURTNEY: Did you survey the district judges to see if they needed law clerks and secretaries?

REPRESENTATIVE VINCENT: It was very conclusive that this help was needed.

CHAIRMAN SCULLY: Would you have any objection if it was acted upon and then held until the bill on the new three district judges came through the committee?

REPRESENTATIVE VINCENT: The interim committee wanted to clarify and expedite and make the judicial system more efficient.

Hearing closed on House Joint Resolution #3.

The committee then went into executive session.

REPRESENTATIVE LORY: I move the adoption of HJR #3.

Second by Representative Dussault.

There was some discussion about whether clerks

and secretaries could be used.

RAY STEWART: New court administration:

It would be 90% funded by the court of criminal control. He explained the kinds of cases, whether civil or criminal,
