

JUDICIARY COMMITTEE

January 12, 1977

The executive session was called to order at 10:00 A. M. in room 436. All members were present with the exception of Representative Kennerly, absent. Chairman John Scully presided.

Action to be taken on House Bill #22 was postponed to Thursday, January 13, 1977.

House Bills #28 and 29 were scheduled for discussion as a pair to be taken together.

REPRESENTATIVE HAND made the motion to "Do Pass".

The motion was seconded by Representative Seifert.

REPRESENTATIVE SEIFERT made a substitute motion to raise the age to 21 years.

REPRESENTATIVE DAY opposed the motion.

REPRESENTATIVE RAMIREZ opposed the motion. He said it does not have a chance of passing on the floor, if raise to 21 years of age.

REPRESENTATIVE COLBURN asked if it could be placed on the ballot stipulating between 19 or 21 years of age.

CHAIRMAN SCULLY said the choice has to be sufficiently narrow.

REPRESENTATIVE CONROY asked the cost of placing it on the ballot.

REPRESENTATIVE ROTH stated about \$2,500.

REPRESENTATIVE HOLMES commented that we have to educate the public.

REPRESENTATIVE CONROY added that the cost of putting it on the ballot should be considered.

REPRESENTATIVE DUSSAULT made a substitute motion "do not pass. The motion was seconded and discussion followed.

REPRESENTATIVE DUSSAULT stated that she felt it would be unfair to punish the majority for the irresponsibility of a few.

REPRESENTATIVE COURTNEY said he was in support of the motion.

REPRESENTATIVE RAMIREZ opposed the motion. "I don't think it is designed soley for the benefit of the teachers".

REPRESENTATIVE KEYSER, spoke in opposition to the motion. I feel this bill will take care of the problem in the schools.

REPRESENTATIVE TEAGUE said he has been in education for 14 years and are having bigger problems than ever before. We have placed

the schools with a very hard and difficult ask.

REPRESENTATIVE HOLMES thought that Billings is the one place that is having the most problems, but felt this bill did not address the problem that we are trying to solve.

REPRESENTATIVE ROTH. I believe that this is a beginning. This is a good bill. I believe that we should raise the drinking age to 19.

REPRESENTATIVE LORY said, I will support the bill because we are taking the democratic process by putting it to the people.
