

EDUCATION COMMITTEE

January 26, 1977

The meeting was called to order at 3:35 p.m., with all members present.

House Bill 315 was discussed. Rep. Dassinger, chief sponsor, said that the bill would allow for release time for religious instruction up to 2 hours a week. It prohibits use of public school property or money. John Frankino and Jan Brown submitted prepared statements in support of the bill (attached). There were no opponents. In closing, Rep. Dassinger said schools would use no class time for this. Mr. Frankino said release time programs have been successful and unsuccessful, but recently are starting to work better.

The Committee then went into executive session.

The subcommittee reported on House Bill 66. The attached amendments were discussed. Rep. Courtney moved adoption of the amendments with alternative (1). There was discussion on how the money is appropriated and from which fund would be best. In answer to a question, Mr. Maclin said the school was not attached to the Department of Justice because it is an educational, not a law enforcement agency. Ray Haas said that if in the future the service becomes large enough to have a great amount of revenue the law could be changed to establish a revolving fund, for fee recovery. The motion to adopt the amendments passed unanimously. Rep. Meyer then moved that House Bill 66 DO PASS AS AMENDED. The motion passed-14-1.

House Bill 69 was discussed. Rep. Barrett reported that the subcommittee has not had time to check the last part of Rep. Fabrega's amendment which puts center directors under the executive officer, and the question on allocation of funding. Rep. Hand moved to wait until Friday and discuss all amendments. The motion passed.

The Chairperson read the attached letter from Gladys Elison about House Bill 199. Rep. Lory moved to change "require" to "allow" on line 4, and "shall" to "may" on line 11. The motion passed 11-4. Rep. Lory then moved House Bill 199 DO PASS AS AMENDED. Rep. Kvaalen made a substitute motion that it DO NOT PASS AS AMENDED. Rep. Lory withdrew his motion. The substitute motion passed 11-4. Rep. Gilligan moved to reconsider action on House Bill 199. The motion to reconsider passed 8-7. He then moved to amend the bill to reinsert the original language. Rep. Hand made a substitute motion that the bill DO NOT PASS, but withdrew the motion. Rep. Gilligan's motion was voted on and failed 7-8. Rep. Lory then moved that House Bill 199 DO NOT PASS AS AMENDED (~~shall~~ allow and may) and the motion passed 12-3.

Rep. Lory moved that HJR 16 DO NOT PASS. Rep. Estenson spoke in favor of the motion, saying this function should be in the Governor's Office under Judith Carlson. The Chairperson suggested tabling this resolution and drafting a committee resolution to that effect. Rep. Lory withdrew his motion and moved to table the bill. The motion passed unanimously. Rep. Estenson moved that the Chairperson draft a committee resolution.

Rep. Lund moved that House Bill 315 DO PASS. The motion was passed 10-5.

There being no further business, the meeting adjourned at 4:50 p.m.
