

JUDICIARY COMMITTEE

SENATE BILL #346:

REPRESENTATIVE BAETH moved "not concurred in".  
The motion carried with the vote unanimous.

SENATE BILL #156:

REPRESENTATIVE LORY moved to "table".  
The motion carried with the vote unanimous.

SENATE BILL #335:

REPRESENTATIVE McLANE moved "be concurred in".  
The motion carried with the vote unanimous.

SENATE BILL #397:

REPRESENTATIVE KEYSER moved "be concurred in".  
The motion carried with the vote unanimous.

SENATE BILL #437:

REPRESENTATIVE RAMIREZ moved "be concurred in".  
The motion carried with Representative Eudaily voting "no".

SENATE BILL #101:

REPRESENTATIVE SEIFERT moved to amend the title, line 6 and page 2, line 1. The motion carried with the vote unanimous.  
REPRESENTATIVE RAMIREZ moved to amend page 2, line 1 and 3, 4 and 5. The motion carried with the vote unanimous.  
REPRESENTATIVE HOLMES moved to amend by changing the number of legislators listed as 5 on page 1, line 22, to "the majority of either house or senate".  
REPRESENTATIVE KEYSER moved a substitute amendment changing the five to fifteen. The motion carries with Lory voting "no".

REPRESENTATIVES LORY and RAMIREZ spoke against the bill.

REPRESENTATIVE KEYSER moved "be not concurred in as amended".  
The motion carried with Representatives Holmes and Courtney voting "no". (copy of amendments as passed attached)

SENATE BILL #115:

REPRESENTATIVE BAETH moved "be concurred in".  
The motion carried with the vote unanimous.

SENATE BILL #262:

REPRESENTATIVE RAMIREZ moved "be concurred in".  
The motion carried with the vote unanimous.

for the day. The motion carried with the vote unanimous.


SENATE BILL #229:
