

MINUTES OF THE APPROPRIATIONS COMMITTEE
HOUSE OF REPRESENTATIVES
State Capitol, Room 225

April 4, 1977

Chairman Bardanoue called the meeting to order at 8:00 a.m. Roll call was taken and a quorum was present; roll call attached. Also present were Curt Nichols, Legislative Fiscal Analyst, and Leslie Simpkins, Office of Budget and Program Planning.

EXECUTIVE SESSION:

House Bill 140: Representative Lynch MOVED that the bill be amended on page 2, section 1, line 11 to delete \$250 and insert \$200, and that the change be inserted where applicable throughout the bill. (Amendments attached). The motion was seconded and question called. ROLL CALL VOTE: The motion carried with a vote of 15-0 (Representatives Estenson and Lund absent).

Representative Lynch MOVED that H.B. 140 AS AMENDED DO PASS. Representative Gunderson made a SUBSTITUTE MOTION that H.B. 140 AS AMENDED DO NOT PASS. ROLL CALL VOTE: The substitute motion failed with 4 voting aye, 11 voting no, and 2 absent.

The vote was reversed to Representative Lynch's motion of AS AMENDED DO PASS. That motion carried 11-4, 2 absent.

House Bill 160: Representative Bradley MOVED H.B. 160 DO PASS. Representative Moore made a SUBSTITUTE MOTION that H.B. 160 DO NOT PASS. ROLL CALL VOTE: The substitute motion failed with a vote of 3 aye, 12 no, and 2 absent.

The vote was reversed to Representative Bradley's motion of DO PASS. That motion carried with a vote of 12-3, 2 absent.

House Bill 161: Representative Bradley MOVED H.B. 161 DO PASS. Representative Moore made a SUBSTITUTE MOTION that H.B. 161 DO NOT PASS. ROLL CALL VOTE: The substitute motion carried with 9 voting aye, 7 no, 1 absent.

House Bill 162: Representative Moore MOVED to amend page 1, line 4 and page 1, line 11, strike \$500,000 and insert \$200,000. VOTE: The motion carried.

Representative Moore MOVED H.B. 162 AS AMENDED DO PASS. ROLL CALL VOTE: The motion failed with a vote of 6 aye, 9 no, 2 absent.

Representative Lynch MOVED that the vote be reversed to AS AMENDED DO NOT PASS. VOTE: The motion carried. Final vote: 9-6, 2 absent.

House Bill 294: Representative Gerke MOVED that the amendments (attached) be adopted. VOICE VOTE: The motion carried unanimously.

Representative Moore MOVED H.B. 294 AS AMENDED DO PASS. VOICE VOTE: The motion carried unanimously.

House Bill 445: Representative Lynch MOVED H.B. 445 DO NOT PASS. Seconded by Representative Moore. ROLL CALL VOTE: The motion carried with 10 voting aye, 2 no, 1 abstain, and 4 absent.

Senate Bill 11: Representative Moore MOVED S.B. 11 BE CONCURRED IN. ROLL CALL VOTE: The motion carried with 15 voting aye, 2 absent.

Senate Bill 72: Representative Moore MOVED S.B. 72 BE NOT CONCURRED IN. ROLL CALL VOTE: The motion carried with 11 voting aye, 4 no, and 2 absent.

The meeting adjourned at 8:50 p.m. to be convened again at the call of the chair.
