

TAXATION COMMITTEE
45TH LEGISLATURE

Rep. Herb Huennekens, Chairman, called the taxation committee to order for an executive meeting April 4, 1977, at 8:00 a.m., in room #434, Capitol Building, Helena, Montana. All members were present except Rep. Harrington.

SENATE BILL 130 - Rep. Robert Sivertsen moved that the 10-year period be reinserted in SB 130, by amending title, line 8, following: "10"; strike: "4"; insert: "10"; and on page 1, section 1, line 19, following: "10"; strike: "4"; insert: "10". Motion carried. Dassinger voted No.

Rep. Sivertsen moved that SENATE BILL 130 AS AMENDED BE CONCURRED IN. Motion carried unanimously. Reps. Harrington, Uhde, Waldron, Vincent were absent. Rep. Bertelsen will carry this bill on the House floor.

SENATE BILL 129 - Rep. Fabrega moved that SB 129 BE CONCURRED IN. Motion carried unanimously. Reps. Harrington, Uhde, Waldron, Vincent were absent. Rep. Bertelson will carry this on the floor.

SJR 2 - Rep. Dassinger moved SJR 2 BE CONCURRED IN. Motion carried unanimously with Reps. Harrington, Uhde, Waldron and Vincent absent. Rep. Fabrega will carry this bill on the House floor.

SENATE BILL 137 - Rep. Fabrega moved SENATE BILL 137 BE CONCURRED IN. Motion carried unanimously. Reps. Harrington, Vincent, Waldron, Uhde were absent. Rep. Mel Williams will carry this bill on the House floor.

SENATE BILL 100 - Rep. Fagg moved SENATE BILL 100 BE CONCURRED IN. Motion carried with Rep. Harrington absent. Rep. Dassinger will carry on the House floor.

SENATE BILL 177- Steve Waldron moved that on page 24, line 23, strike: "\$10", insert: "\$25"; and on line 24, strike: "\$50"; insert: "\$100".

Rep. Fagg moved to amend the proposed amendment up to \$250 on lines 23 and 24. This would make the fine at the judge's discretion up to \$250. Motion carried with a 10-6 vote in favor of this amendment.

Rep. Williams moved that the original language of the bill be reinserted - to remove amended language. Terry Cohea will check on a Wisconsin law regarding use of a road to get from where snowmobiles are unloaded up to the area where snowmobiles are permitted to operate. Rep. Vincent also suggests a requirement that the decal be big enough to be seen from a distance.
