

MINUTES OF THE MEETING
SENATE STATE ADMINISTRATION COMMITTEE
JANUARY 22, 1977

The meeting was called to order at 8:00 a.m. in Room 410 of the Capitol Building by Senator Towe, Chairman. Senators present were Senators Towe, Story, Brown, Rasmussen, Roskie, Jergeson, Blaylock, and Devine.

The following bills were discussed: SB50
SB 71

SB 50 Senator Story, sponsor of the bill, stated he had mixed feelings when he first contemplated the bill. He felt at that point the Department was doing more than the law required but less than he wanted them to do. The Department of Community Affairs has expressed a wish to work with the census people in changing the enumerator districts in the state. He hoped that organizations and businesses needing information would be charged for the materials they use. He stated the Department would also compile a Montana gross product.

SENATOR ROSKIE MOVED TO AMEND THE BILL ON PAGE 3, LINES 2, 3, AND 4 (SEE ATTACHED COMMITTEE REPORT). THE MOTION CARRIED UNANIMOUSLY.

SENATOR ROSKIE MOVED SB 50 DO PASS AS AMENDED. THE MOTION CARRIED WITH SENATOR TOWE VOTING NO.

SB 71 The committee considered amending lines 4 and 15 on page 3 and striking section 3 but after discussion decided against such action.

SENATOR BLAYLOCK MOVED TO AMEND PAGE 2, LINE 23, BY STRIKING 22,500 AND INSERTING 21,000. THE MOTION CARRIED UNANIMOUSLY.

Senator Blaylock stated he felt we should pay Montana officials fair salaries but salaries based on Montana and not other states. He felt they are entitled to an increase, but not such a high level one. Senators Roskie, Devine and Jergeson expressed agreement.

In reviewing the Governor's salary, it was noted there are 20 people in the University system alone who are higher paid than the Governor. However, note was made of such perquisites as house, car, travel, food, etc., which were taken into consideration.

SENATOR BROWN MOVED PAGE 3, SECTION 2, LINE 12, BE AMENDED BY STRIKING 42,500 AND INSERTING 40,000.

SENATOR BLAYLOCK MOVED TO AMEND PAGE 3, SECTION 2, LINE 16 BY STRIKING 40,000 AND INSERTING 35,000. SENATOR STORY MADE A SUBSTITUTE MOTION TO AMEND PAGE 3, SECTION 2, LINE 16 BY STRIKING 40,000 AND INSERTING 32,500. THE MOTION CARRIED WITH SENATORS JERGESON AND BLAYLOCK VOTING NO.

SENATOR BROWN MOVED TO ACCEPT THE 25,000 FIGURE ON PAGE 3, SECTION 2, LINE 17. THE MOTION CARRIED UNANIMOUSLY.

SENATOR BLAYLOCK MOVED TO AMEND PAGE 3, SECTION 2, LINE 18 BY STRIKING 38,000 AND INSERTING 30,000. THE MOTION CARRIED UNANIMOUSLY.

SENATOR BROWN MOVED TO ACCEPT THE \$25,000 FIGURE ON PAGE 3, SECTION 2, LINE 21. THE MOTION CARRIED UNANIMOUSLY.

SENATOR STORY MOVED TO ACCEPT THE 25,000 FIRGURE ON PAGE 3, SECTION 2, LINE 21. THE MOTION CARRIED UNANIMOUSLY.

SENATOR BROWN MOVED TO AMEND PAGE 3, SECTION 2, LINE 22, BY STRIKING 25,000 AND INSERTING 17,500. SENATOR JERGESON MADE A SUBSTITUTE MOTION TO AMEND PAGE 3, SECTION 2, LINE 22, BY STRIKING 25,000 AND INSERTING 19,500. THE MOTION CARRIED WITH SENATORS TOWE, STORY AND BROWN VOTING NO.

SENATOR JERGESON MOVED TO AMEND PAGE 4, SECTION 3, LINE 2, BY STRIKING 40,000 AND INSERTING 32,500. SENATOR ROSKIE MADE A SUBSTITUTE MOTION TO AMEND PAGE 4, SECTION 3, LINE 2, BY STRIKING 40,000 AND INSERTING 35,000. SENATOR RASMUSSEN MADE A SUBSTITUTE MOTION FOR ALL MOTIONS PENDING TO AMEND PAGE 4, SECTION 3, LINE 2 BY STRIKING 40,000 AND INSERTING 37,500. THE MOTION FAILED ON A ROLL CALL VOTE WITH SENATORS BROWN, ROSKIE, JERGESON, AND BLAYLOCK VOTING NO.






