JOINT CONFERENCE COMMITTEE REPORT ON
HOUSE AMENDMENTS TO SENATE JOINT RESOLUTION NO. 1

The Joint Conference Committee met in room 331 of the capitol on January 24, 1977, to consider amendments in lieu of the House amendments to SJR 1. Present were Senators Murphy, Roberts and Turnage; Representatives Driscoll, Meloy and Marks.

Senator Murphy handed out a copy of the proposed senate amendments to SJR 1, 6-7. A discussion was held on these amendments.

Senator Turnage moved that the amendments be adopted with the following changes: (amendments attached as exhibit 1)

In the second paragraph, line 5, change 30th to 40th. More discussion was held. Then the motion was seconded by Representative Driscoll. This second was followed by more discussion.


Representative Meloy moved a substitute motion to accept the amendments with the following changes:


First paragraph, 2nd line, strike "2/3 vote of." In the second paragraph, 3rd line, strike "2/3 vote of," and in line 4, change 30th to 40th. More discussion followed.

The motion by Meloy was seconded by Representative Driscoll. The question was called. Voting yes were Murphy, Turnage, Meloy, Driscoll and Roberts. Voting no was Representative Marks. Motion carried.

The meeting was adjourned at 5:15 p.m.

Proposed amendments to Senate Joint Resolution 1.

Amend JR 6-7

On page 22, line 18, after the word "bills", insert "approved by 2/3 vote of the rules committee of the house in which the committee bill originated.

On page 23, lines 2 and 3. Strike the lines in their entirety. Insert; "Revenue bills must be introduced by 5:00 p.m. on the 25th legislative day. Committee bills approved by 2/3 vote of the rules committee of the house in which the committee bill originated may be introduced by the 30th legislative day. There is no time limit for introduction of the appropriation bills."

Insert: "", Committee Bills approved by the rules committee of the house in which the committee bill originated"


2. Amend page 23, section 6-7, line 3.


Following: "day."


Insert: "Committee bills approved by the rules committee of the house in which the committee bill originated may be introduced by the 40th legislative day.




