#### MINUTES OF THE MEETING LOCAL GOVERNMENT COMMITTEE MONTANA STATE SENATE

February 3, 1977

Insert: "The council or legislative body shall satisfy the requirements of this subsection if it mails one absentee ballot to the freeholder or freeholders shown on the last tax roll at the address to which tax notices are sent."

2. Amend page 4, section 1, line 10. Following: "election."

Insert: "The failure of the council or legislative body to comply with this subsection shall not be invalidate an election unless such failure was deliberate."

Gorham Swanberg proposed the following amendment to Senate Bill 199:

1. Amend page 2, section 1, line 10.
Following: "writing"
Insert: "addressed to the address to which tax
notices are sent"

Senator Thiessen moved the amendment to Senate Bill 199. Senator Lockrem seconded the motion. Motion carried. Senator Thiessen moved that Senate Bill 199 be given "And as so Amended, Do Pass" recommendation. Senator Lockrem seconded the motion. Motion carried unanimously.

Senator Thiessen moved the above amendments be adopted to Senate Bill 232. Senator Lockrem seconded the motion. Motion carried.

Senator Lockrem moved the following amendment be adopted to Senate Bill 232:

1. Amend page 4, section 1, line 5.

Following: "by"

Strike: "subsection"

Insert: "11-507"

Senator McCallum seconded the motion. Motion carried.

Senator Thiessen moved that Senate Bill 232 be given "And As So Amended, Do Pass" recommendation. Senator Lockrem seconded the motion. The Chairman called for a roll call vote (attached). The motion carried.

Senator Watt moved to reconsider Senate Bill 164 and hold it in committee. Senator Lockrem seconded the motion. Motion carried.
