Senator Story moved to strike section 10 in its entirety. THE MOTION CARRIED WITH SENATORS TOWE, BLAYLOCK, AND JERGESON VOTING NO AND SENATOR BROWN WISHING TO BE RECORDED AS A RELUCTANT AYE.

Senator Roskie moved to amend page 5, line 14 by striking "act" and inserting "section". THE MOTION CARRIED UNANIMOUSLY.



- "43-103. Liversing of Lobbyists fae expiration suspension or revocation - reinstatement. (1) Licenses - fees - oligibility. Amy person of adult ago and good moral character who is a citizen of the United States and otherwise qualified under this act may be licensed as a lobbyist as herein provided. The secretary of state shall provide for the form of application for license. Such application may be obtained in the office of the secretary of state and filed therein. Upon approval of such application and payment of the license fee of ten dollars (\$10.00) to the secretary of state, a license shall be issued which shall antitle the licensed to practice lobbying on behalf of any one or more principals. Each license shall expire on December 31 of each edd evennumbered year. We application shall be disapproved without affording the applicant a hearing which shall be held and decision entered virule ten (10) days, of the date of filing of the application. The license fees collected by the secretary of state under this act shall be deposited by him in the state treasury.
- in writing to the attorney general of the state of Montana charging the holder of a license with having been guilty of unprofessional communion with having procured his license by fraud or perjury or through other, the attorney general is hereby authorized to bring civil action in the district court for Lewis and Clark county, state of Montana, against the holder and in the name of the state as plaintiff to revoke the license. Hearing shall be held by the court unless the defendant-licenses demands a jury trial. The trial shall be held as soon as possible and at least
