

MINUTES OF THE MEETING
LOCAL GOVERNMENT COMMITTEE
MONTANA STATE SENATE

February 11, 1977

The meeting of the Local Government Committee was called to order by Chairman McCallum on February 9, 1977 at 9:34 A.M. in Room 410 of the State Capitol Building.

ROLL CALL: All members were present.

The following visitors were present: Robert E. Arras, Clerk & Recorder, Missoula; Richard Klinger, Yellowstone-Tongue APO; Middle Yellowstone APO; John Bell, Clerk & Recorder; Glen Drake, League of Cities and Towns, Tom Hager, Sponsor; Dean Zinnecker, Montana Association of Counties.

CONSIDERATION OF SENATE BILL 360: Senator Devine, Sponsor of Senate Bill 360, sponsored this bill at the request of the Public Service Commission. This bill deals with the Public Service Commission setting rates for sewer. Senator Devine ask the committee to table the bill until House Bill 238 is received as they deal with the same subject. Glen Drake, League of Cities and Towns, agreed with Senator Devine. Senator Watt made a motion to table Senate Bill 360. Senator Peterson seconded the motion. The motion carried with Senator Lockrem voting "no".

CONSIDERATION OF SENATE BILL 353: Senator Hager, District 30, Sponsor of Senate Bill 353, stated this bill redefined trailer courts and purposes of trailer courts. Richard Klinger, Yellowstone-Tongue APO and Middle Yellowstone APO, stated the purpose of this bill is to eliminate the possibility of some problems occurring in this state that have occurred in neighboring states to the south. This being sanitation problems occurring where mining companies have trailers for employees.

CONSIDERATION OF SENATE BILL 313: Senator Hager, Sponsor of Senate Bill 313, stated he had introduced the bill at the request of John Bell and introduced Mr. Bell. John Bell, Montana Association of Clerks and Recorders, stated Senate Bill 313 would allow Clerks & Recorders overtime pay. Robert Arras, Missoula, stated he was in agreement with Mr. Bell and discussed the Procedures on Elections Manuel for Missoula County (attached).


Dean Zinnecker, Montana Association of Counties, stated Clerks and Recorders know the duties and salaries
