FISH AND GAME COMMITTEE

MONTANA STATE SENATE

February 18, 1977

The sixteenth meeting of the Fish and Game Committee was called to order by Chairman Dunkle at 8:00 A.M., in Room 405 of the State Capitol Building.

ROLL CALL: All members were present with the exception of Senators Warden and Manley, who were excused.

DISCUSSION OF SB 203, an act to generally revise the penalties for fish and game violations, and creating a point system for license revocation.

Debbie Schmidt, Legislative Researcher, went through the proposed amendments. (Attachment #1).

Mr. Orville Lewis, Chief of the Law Enforcement Division of the Montana Fish and Game Department, said he felt this bill would give judges more latitude.

Chairman Dunkle asked the committee if there were questions.

Senator Smith felt that on page 2, line 4 of the bill, the word "buffalo" should be changed to "bison."

Senator Smith made a motion that the proposed amendments, including his own, be adopted. The motion was seconded by Senator Lensink and carried unanimously..
