CONSIDERATION OF HOUSE BILL 14:

Dave Cogley from the office of the Code Commissioner, Legislative Council, explained that this recodification bill gave the power to solemnize marriages to the justices of peace.

DISPOSITION OF HOUSE BILL 14:

Senator Towe moved that H.B. 14 BE CONCURRED IN. The motion carried unanimously.

CONSIDERATION OF HOUSE BILL 27:

Bob Pyfer from the office of the Code Commissioner, Legislative Council, appeared on this bill.

DISPOSITION OF SENATE BILL 402 (Cont'd from 2/22/77):

At this time the committee returned to the amending of S.B. 402. Sen. Towe moved the adoption of the amendments through page 10, lines 5 and 6, and the motion for each amendment carried unanimously. Senator Warden moved the adoption of all amendments subsequent to page 10, lines 5 and 6, including those proposed by Greg Morgan, Montana Bar Assn., and Gerald Neeley, Montana Medical Assn., and each of these motions carried unanimously also. Senator Warden then moved to amend the title by adding "; AND PROVIDING AN INMEDIATE EFFECTIVE DATE", and adding a new section for this. This motion also carried unanimously. Senator Towe had been excused at 11:00 a.m. to attend the State Administration meeting as he is chairman of that committee.

Senator Warden then moved that S.B. 402 as amended DO PASS. The motion carried unanimously with Senator Towe approving the amendments made by Senator Warden and casting an affirmative vote on this motion. (For all amendments to S.B. 402, see Exhibit 1)

The fund may not become a part of or revert to the general fund of this state but shall be open to auditing by the legislative auditor.

(2) To create the fund, an annual surcharge shall be levied on all health care providers. The amount of the assessment shall be set by the director, who shall allocate a projected cost among health care providers on a per capita basis. The director may provide a different allocation upon approval by the supreme court. Surplus funds, if any, over and

above the amount required for the annual administration of the act shall be retained by the director and used to finance the administration of this act in succeeding years, in which event the director shall reduce the annual assessment in subsequent years, commensurate with the proper administration of this act.

(3) The annual surcharge is due and payable on the same date as license fees payable to the state of Montana are due."
