Representative William Menahan, District #90, stated he was chief sponsor of this bill. He stated this bill simply deletes portions of Section 40-3909 which are the figures at the bottom of page 2. He stated in group life insurance there are limits right now. The life insurance industry wants to eliminate this so that they can write the policy their own way.

Senator Regan stated one of the problems of insurance earlier was that the insurance companies were refusing to insure new born babies and they passed the law doing so. In anyway are we affecting that law by deleting this?

Roger Tippy said "no."

#### PROPONENTS:

Josephine Driscoll, Auditor's Office, stated this has nothing to do with the other in regard to Senator Regan's question. This pertains only to group life. Mrs. Driscoll stated the limits were so outdated so they were deleted. This is essential to update this a little bit. She does not anticipate any abuses.

Senator Mehrens made a motion that HB 709 Be Concurred In. Senator Peterson seconded. All were in favor.

Senator Mehrens will carry the bill on the floor.

ADJOURN: There being no further business, Vice Chairman Regan adjourned the meeting at 11:15 a.m.
