Senator Goodover made a motion that the bill As Amended, Be Concurred In subject to reconsideration of the fees and the receiving of the audit which has been made. Senator Lowe seconded. All were in favor.

HOUSE BILL 245.

Senator Kolstad made a motion that this bill Be Not Concurred In. Senator Regan made a substitute motion that this bill Be Concurred In. Roll call vote. 4-4. Came out of committee Without Recommendation
