FISH AND GAME COMMITTEE
MONTANA STATE SENATE

March 25, 1977

The twenty-third meeting of the Fish and Game Committee was called to order by Chairman Dunkle at 8:00 A.M., in Room 405 of the State Capitol Building.

ROLL CALL: All members were present, with the exception of Senator Warden, who was excused.

CONSIDERATION OF HB 635, an act to increase the amount of money deposited to the state parks account in the earmarked revenue fund from the gasoline dealers' license tax.

Mr. Ron Holliday of the Montana Department of Fish and Game testified in support of the bill, saying the funds are badly needed to keep the State Park system functioning at the present level. (Attachment #1).

Mr. Michael Koehnke, representing the Budget and Program Planning Division of the Governor's office, testified in support of the bill.

Mr. Earl Moritz, President of the Montana Highway Users' Federation, testified in opposition to the bill. He said his purpose in speaking was to point out to the committee the condition of the Montana highway road system and the damage of allowing diversion of highway funds. He said Montana roads are deteriorating rapidly, and there is a desperate need to upgrade, repair and improve the present highway system if we are to maintain our precious freedom of mobility. He also mentioned that many of our roads and streets were constructed decades ago and are dangerous, presenting hazards to life and property. (Attachment #2).

Chairman Dunkle opened the meeting to discussion. Mr. Koehnke explained how the budget is set for earmarked funds. He said no general funds are needed, but other funds are.

Representative Harrison Fagg, Chief Sponsor of the bill, spoke in its support. He said it would give the opportunity to keep parks open. He also suggested a user fee.

DISPOSITION OF HB 635: Senator Smith made a motion that HB 635 be tabled. The motion was seconded by Senator Manley. Chairman Dunkle called for a roll call vote. The vote passed, with Senators Galt and Lowe voting no.

CONSIDERATION OF HB 644, an act establishing a Montana State Golden Years Pass which will allow senior citizens to enter state parks and recreational areas for a nominal administrative fee.

Proposed amendments to the bill were presented and discussed. (Attachment #3).

Mr. Wes Woodgerd of the Montana Fish and Game Department said the bill was amended extensively in the House and, in fact, came out with one amendment which no one suggested or intended. He said that on page 9, line 9, the age for a person to be eligible to hunt birds and fish and a \$1 conservation license was inadvertently raised from 62 to 65. He mentioned he would hope the amended language could be taken out and be left as it has been for a number of years. (Attachment #4).

DISPOSITION OF HB 644: Senator Lowe made a motion that HB 644 BE CONCURRED IN AS AMENDED. The motion was seconded by Senator Smith. Senator Dunkle called for a roll call vote. The motioned carried unanimously.

ADJOURNMENT: There being no further business to discuss, Chairman Dunkle adjourned the meeting at 9:10 A.M.

Exhibit 10, '77 Testimony with regard to House Bill No. 635 amending Section 32-2601

R.C.M. 1947 of the gasoline tax law to provide 9/10 of 1% of all revenues to be deposited in the state park earmarked revenue fund for the operation, improvement and maintenance of State parks where motor boating is allowed--
Ron Holliday, Administrator, Recreation and Parks Division, Department of Fish and Game.

In 1965, the legislature transferred the state parks system from the Department of Highways to the Department of Fish and Game. At that time the state parks system was funded entirely by the general fund. Since that time, earmarked revenues, such as motorboat fuel tax, and earned revenues, such as overnight camping fees, have been added. Fish and Game has recognized the state park system as an important addition to the department and has striven to continually improve the system. Further, it has been expanded through legislative actions such as the Bicentennial Headwaters State Park ^{WATERFACER'S STATE PARK ON FLATHEAD LAKE} and the Giant Springs State Park ^{AND OTHERS.} at ~~Great Falls~~. Funding of the system from the traditional sources mentioned above, including the gas ^{GAS} tax, has never been adequate to properly operate and protect a modern state park system in Montana without leading the department into the position of diverting hunting and fishing earmarked monies. Indeed, this possible diversion is, as you ^{PROBABLY} know, very much in discussion at the moment.

^{AND OUR DEPARTMENT}
The Office of Budget and Program Planning, in order to make up the difference necessary to adequately maintain the park system out of legitimate revenues at the present level has recommended several alternate sources of fundings. Among them is an increase from .6% to .9% in the allotment of the gas tax to parks. This recommendation resulted in HB 635 and my testimony today concerns the rationale behind that requested increase.

Requests for the recreation dollar from many diverse recreational groups appear to be increasing at a pace faster than the dollar itself is generated. One method that has been used by many states to partially offset the costs of providing recreation opportunities for the public has been with fuel taxes based directly on recreational use.

Presently, the only tax of this nature in Montana is based on motorboat fuel usage. In response to increasing demands for recreational facilities from many different user groups and the limitations of present funding sources, it was felt that some assessment should be made of the potential of additional sources of funds. The need for this assessment is also evidenced by recent legislative proposals for allocating revenues based upon snowmobile fuel usage in Montana. This survey of present fuel tax allocations nationwide was also undertaken in response to a recommendation to review existing legislation in other states contained in a 1974 report to the Recreation and Parks Division entitled "Snowmobiles and Off Road Vehicles in Montana; a review of literature" by W. C. Hollenbaugh.

METHODS

A simple one-page questionnaire and stamped, addressed return envelope were mailed to the State Liaison Officers (SLO's) for Outdoor Recreation of all 50 states and 5 territories early in September. It was assumed that they would be most knowledgeable about tax funds allocated to recreation in their respective states although in many states these allocations are not made through the SLO's Office.

Briefly, four questions were asked: "Is a portion of your state motor fuel tax allocated for recreational purposes?, Is it based on fuel usage and, if so, what kind?, What percent of the total fuel tax is it? and, How is the amount decided upon?" Also, 21 states were identified as "snowbelt" states where it might be expected that snowmobile fuel usage would be substantial. A second page was added to the questionnaire containing similar questions for the snowbelt states below:

My name is Earl Moritz, President of the Highway Users Federation for Montana.

My purpose for appearing before this committee is not to deny the Motor boats the right to collect their refunds, as they already can file for them on forms provided by the Department of Revenue. My purpose is to point out to this committee the condition of the Montana Highway Road System and the damage of allowing diversion of highway funds.

Montanas roads are deteriorating rapidly. There is a desperate need to upgrade, repair and improve our present highway system if we are to maintain our precious freedom of mobility. Many of our roads and streets were built decades ago and are dangerous, presenting hazards to life and property.

According to figures provided by the Montana Department of Highways there are 2,843 miles of primary and rural extension roadways that are in dire need of reconstruction. At todays cost, this would be approximately \$882,000,000. And this does not include Secondary Highway System. In addition there are 146 bridges that need replaced because of structural and width deficiencies.

Now if that doesn't scare you, let's consider the Interstate System. To date there are 109.458 miles of 4 lane interstate and 176.310 miles of 2 lanes to be added at an estimated cost of \$327,800,000 as of 1976 cost. This means that the total cost to meet todays needs at todays prices is approximately \$1.2 billion dollars.

Now, how much money does the Department of Highways actually have to work with? Last year the net gasoline taxes collected were \$36,510,469. For the next fiscal year there are several proposals to divert more money from this account

Statement Requesting Amendments to HB 644
Department of Fish & Game -- Wes Woodgerd, Consultant

This bill was amended extensively in the House and, in fact, came out with one amendment which no one suggested or intended.

On page 9, line 9, the age for a person to be eligible to hunt birds and fish for a \$1.00 conservation license was inadvertently raised from 62 to 65. I would hope the amended language here could be taken out and leave it as it has been for a number of years.

I would also like to suggest the other amendments on page 9 be lifted from here and reinserted on page 14. The situation here is an amendment in Title 26, the Fish & Game law, to allow persons over 65 to camp in state-administered parks and recreation areas on a golden years pass. This amendment rightfully belongs in Title 62, the State Parks laws, inasmuch as it refers only to camping privileges. If this were done, there would be no amendments left in Title 26 and 90% of the total bill could be eliminated. The only change in law would be included in the last paragraph (page 14, starting on line 6).

The present language with an amendment would become subsection (1) and the amendment brought over from page 9 would become subsection (2).

The Fish and Game Committee of the Senate was called to order by Chairman Dunkle at 5:05 P.M., in Room 405 of the State Capitol Building.

Senator Galt was the only member present.

CONSIDERATION OF SENATE RESOLUTION 6, a resolution of the State of Montana urging that public lands not be closed by any blanket edict, but should be open to all forms of recreational use, including snowmobiles, unless closed for a specific reason on an individual area basis.

Senator Manley entered the meeting at 5:10 P.M.

Chairman Dunkle opened discussion on the resolution. Mr. Gene Spilde, representing agricultural interests, said he was neither a proponent or an opponent, but merely wanted to discern what the bill was intended to do.

Senator Dunkle explained that Senator McOmber, Chief Sponsor of the bill, indicated lands should not be closed on a blanket basis, but on an individual basis.

Senator Manley said he felt Senator McOmber's intent was to conserve fuel. Chairman Dunkle announced that the resolution has nothing to do with state lands.

Mr. Spilde said, after having the resolution explained, that he had no objections to it.

Senator Lensink enter the meeting at 5:15 P.M., and after hearing the discussion, said the resolution sounded excellent to him.

Because of a Democratic caucus, the committee did not have a quorum present and therefore no action was taken on the resolution.

ADJOURNMENT: Chairman Dunkle adjourned the meeting at 5:20 P.M.
