

MINUTES

SENATE RULES COMMITTEE

The Senate Rules Committee met on March 28, 1977 in room 331 of the capitol. Senator Stephens called the meeting to order at 3:25 p.m. All members were present.

Senator Stephens said that the issue under discussion was Senate Joint Resolution 45, calling for an interim study.

Senator Hazelbaker moved that Senate Joint Resolution be given a "DO PASS". Motion seconded by Senator McOmber and approved by a voice vote unanimously.


Senator Murphy moved that the chairman of the committee move on the floor of the Senate to suspend the rules and accept House Joint Resolution 93. Motion agreed upon unanimously.

Senator Thiessen moved that Senate Joint Resolution 13 be given a committee recommendation of "DO PASS." He stated that he has received lots of mail on it and he felt that the committee should act on it.


General discussion was held briefly. Senator Stephens asked Senator Thiessen if he would hold off on the motion until they could check the status of another Senate Resolution introduced on the same subject. Senator Thiessen agreed, and the motion was withdrawn.

There being no further business, the meeting was adjourned at 3:46 p.m.
