EXECUTIVE SESSION

- HB 492 Sen. Towe moved the adoption of the attached amendments except for amendment #6. The motion carried unanimously. Sen. Murray moved the adoption of amendment #6. That motion also carried unanimously. (See Attach. #1) Sen. Roberts then moved that HB 492 as amended BE CONCURRED IN. The motion carried unanimously.

- HB 787 Sen. Regan moved to strike "original" on page 6, line 7. The motion carried unanimously. She then moved that HB 787 as amended BE CONCURRED IN. The motion carried unanimously.
- HB 800 Sen. Olson moved to amend page 1, line 22, by striking "\$500" and inserting "\$1,500"; and to amend page 6, line 22, by striking "MORE THAN THREE CLAIMS IN ANY CALENDAR YEAR" and inserting on line 23 "(6) No party may file more than three claims in any calendar year." and then renumber the subsequent subsection. The motion carried unanimously. Sen. Warden then moved that HB 800 as amended BE CONCURRED IN. The motion carried unanimously.
