There is appropriated from the general fund the sum of \$3,000,000 to be used to implement this act for the fiscal year ending June 30, Senator Peterson seconded the motion. Motion carried. Senator Dunkle moved House Bill 521 be given an "And As So Amended, Be Concurred In" recommendation. Senator Peterson seconded the motion. Motion carried.
