MINUTES OF THE MEETING TAXATION COMMITTEE MONTANA STATE SENATE

April 14, 1977

The seventieth meeting of the Taxation Committee was called to order on the above date in Room 415 of the State Capitol Building by Chairman Mathers at 8:10 a.m.

ROLL CALL: Roll call found all of the members present.

ment of Natural Resources presented the bill in the absence of the sponsor, as the bill was at the request of the Department. He said the bill's main thrust is on page 4, line 9, where it specifies that it appropriates money to the Board of Natural Resources to make loans from the renewable resources program. He said the remainder of the bill is a cleanup of existing language. He continued, saying this bill will limit the amount of money the board can loan out to \$5 million; without the bill the board can loan out all of the money in the act.

The Chairman called then for other proponents or opponets and there being none, permitted questions from the committee. Following this discussion the committee agreed to move the bill.

DISPOSITION: Sen. Towe Moved HB779 Be Concurred In. The motion carried with Sens. Goodover, Roskie and Mathers casting "No" votes.

The committee then took up HB737, previously heard by them and following discussion of the bill, took action on it.

Sen. Towe Moved to Adopt the amendments, see committee report attached. The motion carried unanimously.

DISPOSITION: Sen. Towe then Moved HB737 As Amended, Be Concurred In. The motion was carried unanimously.

Following this, the committee then addressed themselves to HB728 and discussed some proposed amendments.

Sen. Watt Moved Adoption of two amendments, see committee report attached; motion carried. Sen. Towe Moved Adoption of an effective date; motion carried unanimously.

DISPOSITION: Sen. Watt Moved HB728 As Amended, Be Concurred In. The motion carried unanimously.

Next up for consideration was HB630. Sen. Turnage introduced amendments as on Exh. #1, attached. There followed discussion of these amendments.

Sen. Roskie then addressed the committee and explained the amendments he favored for the bill. Copies of the bill, with these

tentative amendments were distributed to the committee for their consideration. As they went through the bill they discussed the changes that were made, the most notable were the amendments eliminating the agricultural land from the bill.

The committee was pressed for time at this point and had to adjourn, with plans to again discuss HB630.

Insert: "Section 3. If House Bill 70 is enacted into law, then in lieu of sections 1 and 2 of this act, there is a new R.C.M. section that reads as follows:

"Class of property - certain recreational vehicles. (1) There is a class of property which includes a pickup camper, travel trailer, including a fifth wheel trailer or motor home which is owned by and is actually used primarily by a person 62 years of age or older who is retired from full amployment and whose total income each year from all sources does not exceed the income limitations set in class of ifteen of this section for a single person or married couple, whichever is applicable.

- (2) A person who applies for this classification must file an affidavit with the department of revenue as to his income, as set forth in class fifteen herein.
 - (3) This class of property is taxed at 7% of market value." "
