

MINUTES  
SENATE RULES COMMITTEE

The Senate Rules Committee met on April 19, 1977 in room 331 of the capitol. Senator Murphy, Vice-Chairman, called the meeting to order at 9:00 p.m. Present were Senators Hazelbaker, McOmber, Murphy, Roberts and Thiessen. Absent were Senators Mathers, Stephens and Turnage.

Senator Murphy explained to the committee that Rep. Gerke requested from the Priorities Committee, that the committee on institutions be funded through the interim. He then said that it is up to the Rules Committee to see if they want to take this to the floor for concurrence.

Senator Thiessen said that he was opposed to doing it this way. He thought that the committee should go the regular way and request a study and go through the legislative council.

Senator Hazelbaker asked if there were any money for travel. Senator Murphy said that the money would come not through the Council but through the appropriations for the institutions.

Senator McOmber said that he had reservations about the philosophy of it. He disagreed of the concept for that committee.

Senator Murphy then explained the request and asked for a motion.

Senator Thiessen moved that the rules committee recommend against allowing interim work for the subcommittee on institutions. The motion carried with Senators Hazelbaker, McOmber, Murphy and Thiessen voting yes; and Senator Roberts voting no.


Senator Roberts then said that he thought there may be some good coming from visiting these institutions during the interim. He thought it could be a useful tool for handling the appropriations for the


institutions.
