The forty third meeting of the Senate Finance and Claims Committee was held in room 331 of the State Capitol. Roll call was taken and the meeting was called to order at 11:08 A.M. by Senator Thiessen, Chairman.

Senator Roberts said he had discussed the language to be put into House Bill 554 and had drafted some, however it was the feeling of the Attorney General that it would be better not to have to put in any unnecessary language which would have to have a legal interpretation, but to leave the language out, just striking the figures. All they really need is for the legislature to say no, and then they will attempt to negotiate.

Motion by Senator Fasbender to reconsider the bill, House Bill 554. Voted and approve, unanimous. 11:11 A.M.

Motion by Senator Fasbender to recede from the language voted on this morning in the bill. Voted, passed, unanimous 11:12 A.M.

Motion by Senator Fasbender that the bill be concurred in as amended. Voted and passed, unanimous, 11:12 A.M. Senator Boylan asked to change his vote to no, accepted by the Chairman, and so recorded.

Senator Thiessen asked what the condition of the LRB bill was, and Senator Fasbender said the recommendations had been made, and the bill would be coming out later.

The meeting adjourned at 11:14 A.M.

#### TESTIMONY

#### SENATE BILL NO. 239

The Montana Department of Agriculture endorses Senate Bill No. 239. This bill primarily provides that the Department will assist agricultural producers and county noxious weed personnel in managing and delineating noxious weeds that significantly affect agricultural production, both crop and range, in the state. This bill is a result of the activities and recommendations of the Department's Governor's Noxious Weed Management Advisory Council created by Governor Judge at the request of the Agricultural Ad Hoc Committee and the Department of Agriculture.

Management of noxious weeds involves a determination of the size and type of infestations and development of plans to control or suppress these infestations in cooperation with producers, local, state, and federal agencies and other groups, such as railroads. These management plans must be prepared on a practical, economical and environmentally acceptable basis. The plans must reflect county management priorities during a period of time three years or greater, because it is virtually impossible to effect permanent controls in a shorter period of Currently, noxious weed infestations are not only increasing in size but are appearing in new locations throughout the state. The Department in performing these functions will attempt to assist local groups in determining those areas in the state in which current chemical management techniques should not be used because of critical wildlife habitat, environmentally fragile areas, and situations in which the cost of the program in a particular area is economically unjustified. The Department will also attempt to resolve the current problem of protecting commercial bee operations while attempting to resolve the noxious weed problem in and around agricultural crops and rangeland.
