

HOUSE RULES COMMITTEE
5 January 1979

Chairman Dussault convened the committee at 5:10 pm, Friday, January 5, in Room 343. Representatives Bardanouye, Brand, Gerke, Moore, Vincent and Dussault were present. Representatives Kvaalen, Ramirez, and Sivertsen arrived after roll call was taken. No members of the committee were absent.

Speaker Gerke brought up the matter of the lobby rule in the House. Representative Vincent moved that the 2-hour lobby rule precedent established by the House in previous sessions be retained until change was directed by the House. Bardanouye, Moore, Ramirez, Sivertsen, Vincent and Dussault voted aye; Brand, Gerke and Kvaalen voted no. The motion carried.

Representative Vincent moved that we retain the 1/2 hour lobby rule following the session until otherwise directed by the House. Bardanouye, Gerke, Kvaalen, Moore, Ramirez, Sivertsen, Vincent and Dussault voted aye. Brand abstained. The motion carried.

Chairman Dussault then opened the House Rules for discussion.

A question on H1-3 was brought to the attention of the committee. It was decided by consensus that the gag rule would not be moved until the work load in the chamber became heavier.

Representative Gerke moved that Chapter 1 be recommended to the body. The motion carried unanimously.

Representative Vincent moved that in H7-1 the name of the Education Committee be changed to the Committee on Education and Cultural Resources. Bardanouye, Brand, Gerke, Moore, Sivertsen, Vincent and Dussault voted aye. Kvaalen and Ramirez voted no. Motion carried.

Representative Vincent moved that the name of the Committee on Public Health, Welfare and Safety be changed to the Committee on Human Services. The motion carried unanimously.

Representative Bardanouye moved that H7 be adopted as amended. The motion carried unanimously.

Representative Vincent moved that H7-2 be amended as follows: On line three, strike: three; on line five, strike: three; insert: other. Vincent spoke for his motion. Ramirez spoke against.

Representative Kvaalen then moved as a substitute motion that H7-2 read as follows: "The committee on rules shall consist of the speaker, the majority leader and two other members of the majority party appointed by the speaker, the minority leader and . . ." Kvaalen spoke for his motion. Sivertsen spoke for the motion. Brand spoke against the motion.

Representative Moore then moved as a substitute motion for all motions pending that H7-2 be retained as it is. Gerke spoke against Moore's motion.
