House Rules Committee 5 January 1979

A roll call vote was taken on Representative Moore's motion. Kvaalen, Moore, Ramirez, Sivertsen voted aye. Bardanouve, Brand, Gerke, Vincent and Dussault voted no. The motion failed.

Chairman Dussault then called for the vote on the motion of Senator Kvaalen. Kvaalen, Moore, Ramirez, Sivertsen voted aye. Bardanouve, Brand, Gerke, Vincent and Dussault voted no. The motion failed.

The vote was then taken on the original motion of Representative Vincent. Bardanouve, Brand, Gerke, Vincent and Dussault voted aye; Evaalen, Moore, Ramirez and Sivertsen voted no. The motion carried.

Representative Gerke moved that H7-2 be adopted as amended. Ramirez requested that the vote be reflected as it was in the prior motion. Without objection, Chairman Dussault ordered that the minutes be so written. Representatives Bardanouve, Brand, Gerke, Vincent and Dussault voted aye. Kvaalen, Moore, Ramirez and Sivertsen voted no. The motion carried.

Representative Ramirez then moved that H7-3 be amended as follows: On page 83, line 6, following: If; strike: a member; insert: 25 members. On page 83, line 7, strike: indicates; insert: indicate.

Representative Gerke made a substitute motion that H7-3 be amended as follows: On page 83, line 6, following: If; Strike: a member; Insert: 10 members. On page 83, line 7, strike indicates; insert: indicate.

Representative Sivertsen then made a substitute motion for all motions pending that the language in H7-3 be amended to use the number 15 rather than 10 or 5.

Following discussion, Chairman Dussault called for a vote on Representative Sivertsen's motion. Bardanouve, Brand, Gerke, Vincent and Dussault voted no. Kvaalen, Moore, Ramirez and Sivertsen voted aye. The motion failed.

A vote was then taken on Representative Gerke's motion. Bardanouve, Brand, Gerke, Kvaalen, Moore, Ramirez, Sivertsen, Vincent and Dussault all voted aye. No members voted no. The motion carried.

Representative Moore moved that the following language be added to the first paragraph of H7-3: "... unless they are referred to a committee." The motion carried unanimously.

A discussion followed about H8-1 and its interpretation in relation to the adoption of the resolution that will be the House Rules. It was decided that a simple majority would be enough to amend or pass this resolution.

Representative Ramirez then moved that the final sentence in the first paragraph of H8-1 be stricken and replaced with "A house

rule may be amended or adopted by a majority vote." Following the discussion, the motion was withdrawn.

It was moved that H8 be adopted as read. The motion carried unanimously.

Discussion then involved the problem with prefiled bills being referred to a committee without a sponsor in violation of the rules. It was agreed that the Majority Leader would make a motion to allow those bills to be introduced and a procedure for doing this was defined.

The meeting was adjourned.
