Chairman Dussault called the committee to order at 4:15 pm in order to consider the final executive action on House Resolution 1, the House Rules. All members were present.



Representative Gerke moved that the motion of Representative Vincent include the changes and that as so amended, HR 1 be adopted. The motion carried unanimously.
