HOUSE OF REPRESENTATIVES JUDICIARY COMMITTEE EXECUTIVE SESSION January 31, 1979

The executive meeting was called to order following the regular meeting on Wednesday, January 31, 1979 at 8:40 a.m. in room 436 of the Capitol Building. All members were present except Representative Eudaily, excused.

HOUSE BILL NO. 352:

Representative Holmes moved to amend and the motion carried. (copy attached)

Representative Holmes moved "do pass as amended" and the motion carried with the vote unanimous.

HOUSE BILL NO. 355:

Representative Holmes moved "do pass". Representative Conroy moved to amend

on line 23. Representative Keedy read the current law to the committee. Representative Kemmis will check repealers of 27-1-814 and following sections. It was voted to pass for the day to wait for more information.

HOUSE BILL NO. 369:

Representative Teague moved "do pass". Representative Kemmis asked about sub-

section 4. He moved to strike, subsection 4, lines 6, 7 & 8 on page 3, and renumber. The motion carried with the vote unanimous.

Representative Lorv moved to amend page 3. line 5. and insert certified. The motion carried with the vote unanimous. He then moved to amend the title also. in a similar manner. This motion carried with the vote unanimous. Also moved to strike lines 9. 10 & 11 of the title. Carried.

Representative Teague moved "do pass as amended". The motion carried with

the vote unanimous.

HOUSE BILL NO. 389:

Representative Keyser moved "do pass". There was general discussion about

the ceiling on the amount.

Representative Seifert moved to amend line 16 and raise the amount to \$5,000.

In further discussion someone suggested that better wording would be "reason ble attorney fees to be set by the court."

The question was called for "do pass" and the motion failed. Representative Keedy moved to send it to the floor without committee recommendation. There was some discussion about this and the motion failed.

> The motion "do not pass" was then back on the table and the motion

carried.

HOUSE BILL NO. 396: Representative Daily moved "do pass" and Representative Keedy, as sponsor of the bill spoke to it, concerning the designation of non-dangerous offenders. Representative Holmes explained the parole board and there was some discussion about this.

The question was called and the vote by roll call was 13 yes, 4 no, and 2 absent. The motion carried.

Representative Keyser moved "do pass" HOUSE JOINT RESOLUTION NO. 15: and the motion carried by 10 yes and 8 voting no.

HOUSE BILL NO. 413: Representative Seifert moved to amend. The motion carried with the vote unanimous. (copy attached) Representative Roth moved "do pass as amended". The motion carried with the vote unanimous.

HOUSE BILLS 368 and 390: Chairman Scully appointed a sub-committee to work with House Bills 368 and 390, and prepare amendments. The sub-committee will be Representative Kemmis, Chairman and Representatives Teague, Seifert, Keedy and Pavlovich. The only instructions were to deal with them in any way they want to, and report by Friday the second of February.
