

PROCEEDINGS OF THE
LOCAL GOVERNMENT COMMITTEE
HOUSE OF REPRESENTATIVES
Monday, February 12, 1979
7:00 a.m.

The meeting was called to order at 7:00 a.m. by Chairman Hershel Robbins for purpose of holding executive session. The secretary called roll and found all members present except Rep. Gould and Rep. South who were excused.

HOUSE BILL 61: The subcommittee report on HB 61 had been submitted to the committee previously. It was then moved by Rep. Reichert to accept the proposed amendments of the subcommittee, which would strike the date of July 1, 1974; insert "existing" before "authorized mill levies on several lines and strike "the means of financing such activity may be through general or special levy...". Vote was called and all voted "aye". Rep. Sales then moved that HB 61 do pass as amended. Rep. Pistoria inquired if this could then be authorized without vote, representatives stated there are other laws dealing with the financing. Vote was called and all voted "aye" except Rep. Pistoria. Motion carried that HB 61 do pass as amended.

HOUSE BILL 118: Rep. Sales moved that HB 118 do pass without amendments. Rep. Vinger then made substitute motion to pass the amendment that this apply to perform those duties required of county superintendents of counties where the office has not been consolidated. Vote was called on the amendment and all voted "aye". Motion was then made by Rep. Sales that HB 118 do pass as amended, vote was called on all voted "aye" except Representatives Pistoria, Vinger and McBride. Motion carried.

HOUSE BILL 318: Representative Pistoria stated he opposed the proposed amendments, stating he would like to see 90 days inserted on page 2, line 11. He then asked to have this bill tabled. There was then further discussion and Rep. Pistoria moved the amendment to give an additional 30 days, vote was called and all voted "aye". Rep. Gould asked to reconsider the amendment, page 2, line 11, changing 60 days to 90 days, and moved this amendment, vote was called and all voted "aye". Rep. Gould then moved HB 318 do pass as amended, vote was called and all voted "aye".

HOUSE BILL 382: There was no discussion and it was moved by Rep. Gould that HB 382 regarding private fire service companies do pass, vote was called and all voted "aye" except Rep. Sales. Motion carried.


HOUSE BILL 381: Rep. Kessler moved that this bill relating to solid waste service do pass. There was then discussion regarding this bill and the similar bill 423. Rep. Gould asked that HB 381 be amended to read 5 years rather than 3. Rep. Donaldson stated 423 already reads 5 years. After further discussion, it was agreed to hold 423 and act on HB 381. Rep. Donaldson then moved that HB 381 be amended on line 16, strike 3 and insert 5, and amend line 20 also, vote was called, all voted "aye" except Rep. Oberg, Kemmis and Kessler, motion carried. Rep. Donaldson then moved amend lines 20 and 17 as shown on the report, vote was called and all voted "aye" except Rep. Oberg, Kemmis and Kessler. Motion carried. Rep. Gould then moved to amend line 2, page 2 from shall to may, vote was called and all voted "aye" except Rep. Oberg and Sales. Rep. Gould then moved that HB 381 do pass as amended, vote was called and all voted "aye" except Rep. Gould. Motion carried that HB 381 do pass as amended.


HOUSE BILL 423: Rep. Sales then moved that HB 423 do not pass. Rep. Sales made substitute motion to table HB 423 and all voted "aye". Motion carried that HB 423 be tabled.

HOUSE BILL 56: Rep. Oberg, chairman of the subcommittee that studied HB 56 stated the committee had recommended several amendments to the bill. He read the proposed amendments and submitted these for discussion. After considerable debate, it was moved that the amendments be considered, and it was then further moved by Rep. Gould that HB 56 be tabled. Vote was called and HB 56 was tabled by unanimous vote.

HOUSE BILL 46: Report from the subcommittee had been given earlier to the committee. Rep. Azzara moved do pass as amended. Rep. Kessler then moved the amendments on page 7 as recommended by subcommittee. Vote was called on the amendments and all voted "aye" except Rep. Sales, Oberg, Gould and Pistoria. Rep. Azzara then moved HB 46 do pass as amended, vote was called and all voted "aye" except Rep. Gould and Rep. Pistoria. Motion carried.

There being no further business, the meeting was duly adjourned at 8:15 a.m. Announcement was made of a meeting to be held the next day at 12:30 pm.
