Chairman Dussault called the meeting to order at 1:45 pm in Room 343. Representative Vincent was excused and Representative Bardonoue was not present until the end of the meeting. All other members were present.

The first question before the committee was whether the Business and Industry Committee amendments to House Bill 526 fell within the scope of the title of the bill. Representative Moore moved that the Rules Committee allow the title to be amended, and amendments of the Business and Industry Committee be found in keeping with the scope of the title. A roll call vote was taken following the discussion. Representative Brand, Gerke, Huennekens, Moore, Ramirez, Sivertsen and Dussault voted aye. Representative Kvaalen voted no. The motion carried.

Representative Moore then moved that HB 237 do pass as amended. Chairman Dussault voted no. All other present members voting aye, the motion carried.

There was a brief discussion about the workload in House committees as it related to transmittal deadline.

Chairman Dussault adjourned the meeting.
