The amendments were studied and revised. There was discussion about the written request of the insured. There was discussion about pain and suffering, how it is covered in Montana.

Representative Keyser moved to strike the new section 13 on page 18, in its entirety. The motion failed with Representatives Keyser, Keedy and Kemmis opposed.

Additional amendments were proposed. Representative Lory moved to amend page 27, line 21, by striking "1980" and inserting "1982". The motion carried.

There was further discussion and the amendments as finalized are attached.

The committee did not offer a recommendation to the full committee. It was decided that they were not authorized to recommend, only study the amendments and fit them into the bill.
