20 February 1979

Chairman Dussault called the meeting to order at 11:35 am, Tuesday, February 20, 1979, in Room 343. All members of the committee were present except Representatives Brand and Vincent.

Chairman Dussault brought to the attention of the Committee HB 837 and HJR 46 both sponsored by Representative Fagg. He was recognized to discuss the bill and resolution. Essentially they were represented as companion measures which propose that committee work be stronger during the interim. Bob Person of the Legislative Council staff was recognized by Chairman Dussault to discuss the fiscal impact of the proposed plan.


There were no other proponents or opponents of the bill and resolution. Questions from the committee followed.

Chairman Dussault then recognized Representative Fabrega to discuss HB 847 of which he was the prime sponsor. Basically this bill would make all interim committee appointments happen in a similar procedure. The committee discussed the bill and suggested that further amendment was necessary.

Representative Huennekens moved that HB 847 do pass, with the assumption that Representative Fabrega would offer clean-up language as a Committee of the Whole amendment. It was the intent of the committee that it be made clear that consultation with the majority and minority leaders not be interpreted as consent of those leaders. The committee voted unanimously in favor of the motion.

Discussion of HB 837 and HJR 46 was resumed. It was agreed that the committee would meet later in the day to try to work these matters into an acceptable form.

Chairman Dussault talked about the committee work load in the house at that time. The meeting was adjourned.
