

HOUSE RULES COMMITTEE
46th Legislature

22 February 1979

Chairman Dussault convened the meeting at 9:10 am, February 22, in Room 343. Representatives Bardanouve, Brand, Kvalen and Sivertsen were absent. All other members of the committee were present.

Representative Fagg was recognized to explain the amendments to House Joint Resolution 46. Representative Vincent submitted suggestions made by Dave Cogley of the Legal Division, Legislative Council staff.

Representative Gerke moved that HJR 46 be amended on page 2, line 23, following: "standing"; insert: "and interim". The motion passed unanimously.

Speaker Gerke then moved that HJR 46 be further amended on page 2, line 25 through line 15 on page 3, by striking that material in its entirety and inserting:

- (1) Agriculture and Business
- (2) Community Affairs
- (3) Finance
- (4) Human Services
- (5) Legal Services
- (6) Resources and Conservation
- (7) Revenue
- (8) State Government".

The motion carried unanimously.

Representative Ramirez moved that HJR 46 be further amended on page 3, line 24 by striking: "advise and oversee executive branch", and inserting: "serve in an oversight capacity to state". The motion carried unanimously.

Speaker Gerke moved that HJR 46 be further amended by striking line 1 on page 4 through line 3 on page 5 in its entirety and inserting new material. Representative Moore made a substitute motion that the old language be stricken, but the new language not be inserted. The motion of Representative Moore carried unanimously.

Representative Vincent then moved to further amend HJR 46 by inserting following line 13: "BE IT FURTHER RESOLVED, that there is a new section in the Joint Rules of the Montana Legislature, numbered 6-6.1 that reads:

"6-6.1 The legislative council may draft any number of bills for each legislator provided that the bill requests are made prior to the first legislative day. Following the first legislative day a legislator may submit not more than two drafting requests to the legislative council. Bills meeting the following conditions do not come under this limit:

(1) the bill has been found to have been drafted in substan-

tially final form by the rules committee of the house in which it was introduced; or

(2) the bill's concept has been presented to an interim committee and was approved during the interim by that committee for drafting."

Representative Vincent's motion carried unanimously.

Speaker Gerke moved that these changes be made effective on adjournment of the regular session of the 46th session. With Representative Vincent voting no, the motion carried unanimously.

Representative Moore moved that each reference to the Committee on Budget and Program Planning be deleted and replaced with the Committee on Finance. The motion carried unanimously.

Representative Ramirez moved that all of these amendments be moved by Representative Fagg as Committee of the Whole amendments and that as so amended that HJR 46, do pass. Representative Moore and Huennekens voted no. All other present members voted aye and the motion carried.

Chairman Dussault recessed the meeting subject to the call of the chair.

The meeting reconvened in the afternoon of the same date. Representatives Dussault, Kvaalen, Moore, Ramirez, Huennekens, Gerke, Bardanouve and Vincent were present. Representative Fagg was also present.


