HOUSE OF REPRESENTATIVES JUDICIARY COMMITTEE EXECUTIVE SESSION March 5, 1979

Following the regular meeting the committee went into executive session in room 436 of the Capitol Building at 10:00 a.m. Monday, March 5. All members were present except Representatives Pavlovich, Seifert, Keedy, Uhde, and Chairman Scully. Representative Teague chaired the meeting until Representative Scully came back from carrying a bill in the Senate. Representative Uhde came in later also.

SENATE BILL NO. 88: Representative Anderson moved "be concurred in". After lengthy discussion it was decided to pass for the day, in order to get more information.

SENATE BILL NO. 104: Representative Holmes moved "be concurred in". The motion carried with the vote unanimous. Representative Rosenthal will carry the bill on the floor.

SENATE BILL NO. 120: Representative Lory moved "be concurred in".

The motion carried with the vote unanimous.

Representative Kemmis moved that it be placed on the consent calendar.

The motion carried with the vote unanimous.

SENATE BILL NO.137: Representative Roth moved "be concurred in".

The motion carried with the vote unanimous.

Representative Roth will carry on the floor.

Representative Keyser moved "be concurred in". After much discussion whether this was covered in the bill revising election laws, Representative Keyser withdrew his motion. It was decided to pass for the day and Representative Eudaily will check to see if it is covered in the other bill.

SENATE BILL NO. 152: Representative Eudaily moved to amend line 24, page 2 by reinserting "justify, or". The motion carried with the vote unanimous.

Representative Holmes moved to amend line 6 of page 4, following line 6, insert: "and must be made within 10 days of the referee's recommendation". The motion carried with the vote unanimous.

Representative Lory moved to strike, "referees" and insert, "departments" on line 11, page 4. The motion carried with the vote unanimous.

Representative Lory moved to amend on page 4, line 22 by striking "referee's written" and inserting, "departments". The motion carried with the vote unanimous

Discussion about who makes the recommendation and who makes the final decision. Much questioning of the wording and the meaning of the wording was carried on. After satisfying everyones questions Representative Lory moved "be concurred in as amended". The motion carried with Representative Iverson voting "no". SENATE BILL NO. 164: Representative Keyser moved "be concurred in". The motion carried with the vote unanimous. Representative Daily will carry the bill on the floor.

SENATE BILL NO. 165: Representative Lory moved "be concurred in" The motion carried with the vote unanimous. Representative Keyser will carry the bill on the floor.

SENATE BILL NO. 197: Representative Keyser moved "be concurred in". The motion carried with the vote unanimous. Representative Kemmis will carry the bill on the floor.

SENATE BILL NO. 204: Representative Keyser moved "be concurred in". The motion carried with the vote unanimous. Representative Keyser will carry the bill on the floor.

Chairman Scully presented the procedure the committee would use to try to coordinat similar bills, suggesting that the sponsors of these bills get together and try to work out whose bill would go through. There was some discussion about this and many opinions were offered as to how this would be carried out. Since there was no further business to come before the committee at this time the meeting adjourned at 11:20 a.m.
