## HOUSE AGRICULTURE, LIVESTOCK, AND IRRIGATION COMMITTEE

March 19, 1979

The meeting was called to order by Vice-Chairman Vicki Johnson at 12:05 p.m. with all members present except Representatives Day, Bengtson, Hand, and Smith.

## SENATE JOINT RESOLUTION NO. 14

REPRESENTATIVE LES HIRSCH, Chairman of the subcommittee, gave the committees report and recommendation. The committee decided that the amendments were not significant to the resolution and they recommended to not adopt the amendments. They decided that by adding the proposed amendments the intent of the resolution would be changed.

REPRESENTATIVE JAMES SCHULTZ, subcommittee member, stated that they felt another resolution should be drafted to the intent of the amendment, instead of amending SJR 14.

REPRESENTATIVE HIRSCH moved to ADOPT THE SUBCOMMITTEES RECOMMENDATION. TO DO NOT PASS THE AMENDMENTS. The motion was carried with Representative Johnson opposed.

REPRESENTATIVE BRAND moved, DO PASS. The motion was carried with Representative Roth opposed.

## SENATE BILL NO. 520

REPRESENTATIVE LIEN moved, DO PASS.

The motion was carried with Representatives Dassinger, Brand, and Johnson opposed.

The motion to DO PASS AS AMENDED was carried unanimously.

## SENATE BILL NO. 509

REPRESENTATIVE LIEN, Chairman of the subcommittee, stated that the subcommittee's recommendation was to BE NOT CONCURRED IN.

The subcommittee met and considered the amendments. They also met with the Board of Regents and came to the conclusion that there is nothing that we can do with SB 509, at this time. The potato growers and the University will have to work out a solution and come up with a bill that we can consider next session.

REPRESENTATIVE LIEN moved, BE NOT CONCURRED IN.

REPRESENTATIVE LIEN then suggested that a committee bill be introduced directing the committee on priorities to conduct a study during the interim on the certification of seeds.

REPRESENTATIVE LIEN withdrew is motion to, BE NOT CONURRED IN, and moved SB 509 BE TABLED. The motion was carried unanimously.

REPRESENTATIVE LIEN moved, TO DRAFT A COMMITTEE JOINT RESOLUTION, directing the committee on priorities to study and resolve the certification of seeds. The motion was carried unanimously.

The meeting was adjourned at 12:45 p.m.
