Mike McGrath - Attorney General


CONSIDERATION OF SENATE BILL NO. 1:

Senator Carroll Graham, sponsor of this bill, explained that he introduced this bill for the code commissioner. He gave a brief explanation of this bill, which refers to the adoption of the Montana Code Annotated. He introduced Diana Dowling, the code commissioner, who answered questions from the committee concerning the contents of this bill.

Senator Turnage questioned many aspects of the bill and made a motion to amend the bill on page 2, line 18, by striking the words "department of administration" and inserting the words, "code commissioner" and again on page 2, line 24. The motion was seconded and carried unanimously.

There were no further proponents of the bill and no opponents. A motion was made by Senator Brown that the bill be passed as amended and the motion carried unanimously.

There being no further business, the committee adjourned at 2:09 p.m.
