
Senate Bill 59 was acted upon.

SENATE BILL 59.

Senator Richard Smith moved to amend page 2, line 8, following "(f)", by striking "breach" and inserting "substantial or material non-performance". The motion carried unanimously.

Following a short discussion Senator McCallum moved Senate Bill 59 Do Pass As Amended. The motion carried unanimously.

There being no further business, the meeting adjourned to reconvene Monday, January 15, 1979.

Section 7. 20-9-433. See explanation for Section 6.

Section 10. 20-9-441. See explanation for Section 6.

Section 11. 20-9-444. Deleted language relating to counties, cities, and irrigation districts. This section is also codified in Title 85, Water Use, as 85-7-2142(1) and Title 7, Local Government, as 7-7-121(1). The deleted language appears in those sections and, therefore, this amendment works no change in meaning.

Section 12. 20-9-465. In (1), changed "not" to "in" to correct an error introduced, apparently typographically, by a 1971 amendatory bill. "In" was changed to "not" in that bill but "in" was not shown as stricken and "not" was not underlined.

Section 13. 20-25-706. In (2), changed "group or factor" to "group or faction" to correct obvious error.

Section 14. 20-30-405. In (2), added "chapter" to correct obvious omission.

Section 15. 20-6-623. This section, requiring further approval of school construction plans by the department of administration after their review by other state agencies, was rendered redundant with 20-6-622 relating to approval by the board of health when "department of administration" was substituted for "board of health" in that section by Ch. 504, L. 1977.

Insert: "Section 14. Audit of community college districts. A community college district is subject to audit by the legislative auditor in the same manner as a state agency. A community college district may contract for an audit with a private accounting firm, subject to approval of the legislative auditor."
