Senator Van Valkenburg gave an explanation of this bill, which is an act to require service of process in actions against the state to be served on the department of administration.

Senator Van Valkenburg introduced Michael Young, administrator of the insurance and legal division, who gave some history in regard to this bill. He stated that it was just a matter of convenience and only applied to tort claims.

Senator Van Valkenburg moved that on page 1, line 15 following "the" that the bill be amended by inserting "director of the". This motion passed unanimously.

Senator Lensink requested that the record show that the secretary of state's office informed this committee that they were in agreement with this bill.

There were no further proponents and no opponents.

Senator Van Valkenburg moved that the bill also be amended on page 1, line 15 following "administration" and insert "in addition to service required by Rule 4D(2)(h), M.R.Civ.P." This motion carried unanimously.

Senator Van Valkenburg moved that in the title, line 6, following "IN", the word "TORT" be inserted. The motion passed unanimously.

#### DISPOSITION OF SENATE BILL 78:

Senator Van Valkenburg moved that Senate Bill 78 pass as amended. The motion carried unanimously.
