SENATE EDUCATION COMMITTEE

JANUARY 19, 1979

The Senate Education Committee met Friday, January 19, 1979, in Room 402 of the Capitol Building. Senator Bob Brown, Chairman, called the meeting to order at 1:30 p.m. Committee members present were Senators Brown, E. Smith, O'Hara, R. Smith, Severson, Fasbender, McCallum, and Blaylock. Senators Anderson and Thomas were excused.

Senate Bill 126 was discussed and acted on.

SENATE BILL 126

Senator Blaylock, sponsor of the bill, deferred to Bob Pyfer, Legislative Council attorney, who explained the bill is strictly a recodification bill and presented the proposed changes according to the Code Commissioner Summary (attached).

Senator Ed Smith questioned the reference to the State Treasurer on page 9, line 5, asking if there is still a State Treasurer. Mr. Pyfer replied that the Director of the Department of Administration has been designated the State Treasurer and so the reference is valid.

PROPONENTS

Marilyn Miller, professional assistant to the Board of Public Education said she supported the bill and proposed an amendment on page 1, lines 19-23 which would bring the bill into conformity with Senate Bill 59 which the committee previously passed.


There being no further proponents and no opponents to the bill, the committee acted on the bill.

Senator Richard Smith moved to amend the bill on page 1 by striking lines 19 through 23 in their entirety following the word "employment" on line 19. (see attached committee report) The motion carried unanimously.

Senator McCallum moved Senate Bill 126 Do Pass As Amended. The motion carried unanimously.

There being no further business the meeting adjourned.
