

MINUTES OF THE MEETING
BUSINESS & INDUSTRY COMMITTEE
MONTANA STATE SENATE

January 22, 1979

The meeting of the Business and Industry Committee was called to order by Chairman Frank Hazelbaker on the above date in Room 404 of the State Capitol Building at 10:00 a.m.

ROLL CALL: All members were present.

Chairman Hazelbaker introduced Randy McDonald from the Legislative Council, and Mr. McDonald explained the changes proposed in Senate Bills 39 and 89. The changes primarily deal with clarification of language and grammar.

SENATE BILL 39: After Mr. McDonald's presentation, Chairman Hazelbaker asked if there were any questions or opposition to the bill. There was none.

Senator Blaylock moved that Senate Bill 39 DO PASS. Senator Dover seconded the motion. The motion was unanimously approved by the Committee.

Senator Goodover moved that this bill be placed on the Consent Calendar. Senator Dover seconded this motion.

Chairman Hazelbaker closed the hearing on Senate Bill 39.

SENATE BILL 89: Mr. McDonald explained proposed changes in this bill.



There were no other questions.

Senator Dover moved we DO PASS Senate Bill 89. This was seconded by Senator Kolstad. The motion was unanimously approved by the Committee.

Senator Blaylock made a motion that Senate Bill 89 be placed on the Consent Calendar. Senator Peterson seconded the motion. All Concurred.
