

MINUTES OF THE MEETING
AGRICULTURE, LIVESTOCK & IRRIGATION
MONTANA STATE SENATE

February 7, 1979

The meeting of this committee was called to order by Senator Conover, acting chairman, on the above date at 12:40 p.m. in Room 415 of the State Capitol Building.

ROLL CALL: All committee members were present with the exception of Senators Kolstad, Aklestad and Nelson who were excused.

CONSIDERATION OF SENATE JOINT RESOLUTION 14: Senator Conover placed SJR before the committee for consideration.

The chief sponsor of SJR, Senator Bob Brown of Kalispell, explained the resolution briefly to the committee and introduced the main proponent of SJR 14, Mr Ron de Yong of the Kalispell area. Mr. de Yong read a prepared statement which explained the resolution as he had written it for Senator Brown. (See attachment #1)

Other proponents who appeared in support of SJR 14 were:

Sharon Peterson, representing WIFE and National Farmers' Org'n.
Ann Page, representing the Montana Farmers' Union

Both of the above proponents simply stated that their organizations were in support of SJR 14.

DISPOSITION OF SENATE JOINT RESOLUTION 14:

Senator Graham suggested that the Secretary of Agriculture be inserted in the directions to whom the resolution is to be sent in Washington, D.C..

Senator Tom Hager moved that the resolution be amended as follows: Page 3, line 1, following line 24 on page 2, inserting: "BE IT FURTHER RESOLVED, that copies of this Resolution be sent to: the President of the United States, the United State's Secretary of Agriculture and Montana's Congressional Delegation." Motion carried.

Senator Hager then moved that SJR, as so amended, DO PASS. The motion carried unanimously.

There being no further business before the committee at this time, they adjourned at 1:25 p.m..
