

MINUTES OF THE MEETING
LOCAL GOVERNMENT COMMITTEE
MONTANA STATE SENATE

February 13, 1979

The meeting of the Local Government Committee was called to order by Chairman George McCallum on Tuesday, February 13, 1979, at 12:30 in Room 405 of the State Capitol Building.

ROLL CALL: All members were present.

Dennis Taylor, staff researcher, was in attendance.

Several visitors were present. (See attachment.)

CONSIDERATION OF SENATE BILL 353: Senator John Manley, of Senate District 14, sponsor of Senate Bill 353, gave a brief resume of the bill. This bill is an act to increase landowner and elector control of zoning by requiring approval of those persons affected before zoning measures are adopted by the Board of County Commissioners; by requiring city-county planning board approval of interim zoning and allowing protest. Senator Manley stated that he felt this bill was very necessary so the people can decide for themselves. He commented that he felt this is a very good piece of legislation. Senator Manley offered some amendments which he felt would only improve the bill.

James Costanagna, Blackfoot Freeholders Association, stated this bill would help insure the rights of landowners in Montana. Mr. Costanagna told that the bill should be amended to include only landowners. If people want zoning they will vote for it.

Charlotte Esther, representing the Environmental Information Center, and Bob Kiesling stated the bill will have a positive effect on planning in Montana, particularly in unincorporated areas adjacent to the State's larger cities. Ms. Esther offered written testimony. (See attachment.)

Alfred Hutchison, of East Missoula, representing the East Missoula and Blackfoot Freeholders, stated that SB 353 would give the people a little weight regarding zoning. Mr. Hutchison told of an example in East Missoula regarding zoning that took place one year ago. (See attachment.)

Albertine (Tina) Fausett, representing the Blackfoot Freeholders Association, commented the people deserve more say in zoning and many are becoming upset with the control. (See attachment.)

Robert Thornburg, East Missoula and Missoula Area Property Holders Association, stated it is essential that the rights of the land owners be protected and the vote of the landowners is what should count for continuation and betterment of property and citizens rights. Mr. Thornburg objected to temporary residents being able to vote.

Walter Vannoy, of Greenough, stated that he was for the bill, as amended. Mr. Vannoy felt that the bill should read freeholders, not just anyone.

Howard Capenhaver, of Ovando, stated his support for the bill, as amended.

David Maclay, representing Land Owners Freeholders, stated that he believes that landowners should have the right to decide whether or not zoning will be placed on the land. Mr. Maclay supports the bill as amended. (See attachment.)

Mr. Lloyd Meske of the Blackfoot Freeholders Association, stated that he was in complete agreement with Mr. Maclay.

Julie Hacker, of Bonner, stated that for the most part, people do not trust county officials anymore. Zoning has set people against each other. This bill would enable people to be made aware. Landowners should have the right to say no. Ms. Hacker felt that landowner control is essential for the good of the country. (See attachment.)

Vera Cahoon, of the Blackfoot Freeholders Association, stood in support of the bill as amended as a way of returning some control to the affected landowners. (See attachment.)

With no further proponents Chairman McCallum called on the opponents. Hearing none, Senator Manley made the closing remarks. Senator Manley stated that this is a start for the landowners and could be implemented into the counties. He asked the Committee to please give Senate Bill 353 a Do Pass, as amended recommendation.

DISPOSITION OF SENATE BILL 353: A motion was made by Senator O'Hara that the amendments that Senator Manely offered be adopted. Motion carried unanimously.

A motion was made by Senator Story that Senate Bill 353 receive a "DO PASS, as amended" recommendation from the Committee. Motion carried.

CONSIDERATION OF SENATE BILL 352: Senator Tom Rasmussen, of Senate District 16, sponsor of the bill, gave a brief resume of the bill. This bill is an act to establish a county compensation board which shall develop a compensation schedule that must be used by the county governing body when setting the salaries for elected county officials.

Bonnie Miller, representing the Montana Clerk and Records Association, stated her support of the bill. Ms. Miller stated that the commissioners need some guidelines in setting salaries for elected county officials. The commissioners from her county,

Powell, favor this bill.

John Bell, representing the Montana Sheriff's and Peace Officer's Association, referred to the Montana Constitution regarding salary setting.

Darlene Hughes, president of the Montana Clerk and Recorders Association, stated her support of the bill and offered some amendments.

R. F. Fisher, representing the Montana Sheriff's and Peace Officers, offered a letter from Dale Dye, president of the Montana Sheriff's and Peace Officer's Association. (See attachment.)

Bill Burley, Lake County Commission, stated his group felt that this was a very good bill. It would take the Legislature out of the salary setting business. Mr. Burley asked the Committee to pass the bill. (See attachment.)

John Muster, Sanders County Commissioner, stated that elected officials need a better system of having their salaries set.

Edith Cox, representing the Montana County Treasurer's Association, stated they would accept the proposed amendments and favor the bill.

Claire Gilreath, representing the Clerk of Courts, stated that they would accept the proposed amendments and favor the bill.

Sheriff Walter Hammermesiter offered an amendment which he handed out to the Committee and thoroughly explained. (See attachment.)

Ray White, Gallatin County Assessor, stated that he felt 11 members could be very cumbersome and the meeting would be costly. Mr. White stated that he is very confused by the bill. He stated the only thing good about the bill is that there is an attempt being made to improve county government.

Mike Stephens, representing the Montana Association of Counties, stated that the bill is a step in the right direction, however, it should be done on the local level completely.

Robert Hoffman, representing the Montana Association of Assessors, stated that he had polled his members, and they all agreed that they did not want the county commissioners to set the salaries.

Al Rierson, sheriff of Flathead County, stated that the responsibilities and duties of the sheriffs are not in unison throughout the state. Mr. Rierson stated that he felt the amendments should be considered as the best single method offered so far.

Perhaps there should be an interim study commission to look into this matter during the next two years, being as this is a new idea.

Ray White, Gallatin County Assessor, spoke again to say he had just read the amended version of the bill and he would support it now.

Glen Osborne, a sheriff, stated that he agreed with Sheriff Rierson and will support the amended bill. Mr. Osborne stated that he favors this amended bill being studied for two years.

Bonnie Miller made the closing remarks for Senator Rasmussen. She stated that she would go along with the offered amendments and asked the Committee to give SB 352 a do pass recommendation.

The meeting was opened to a question and answer period from the Committee. Discussion was held.

A motion was made by Senator Thomas that the amendments proposed for SB 352 be adopted. Motion carried.

Dennis Taylor, staff researcher, was instructed to draft the amendments. It was pointed out that this bill needs a fiscal note.

DISPOSITION OF SENATE BILL 229: Dennis Taylor explained the proposed amendments. The amendments will protect those whose tax base has dropped.

A motion was made by Senator Thomas that the amendments proposed be given a "DO PASS" recommendation. Motion carried.

A motion was made by Senator Thomas that Senate Bill 229 be given a "DO PASS, as amended" recommendation from the Committee. Motion carried.

SENATE BILL 290 REOPENED: Because of lack of time at the previous hearing, it was decided to allow Senator Dover to finish his hearing on Senate Bill 290.

Senator Dover stated that he had gotten together with the power companies and worked out some of the questions which had arisen. He handed out proposed amendments to the bill.

A motion was made by Senator O'Hara to accept the proposed amendments. Motion carried.

Mr. Dave Menter stated that the figure of 200 feet above ground would give the pilots something to work on. He stated one problem is on Boulder Pass. The power lines are less than 200 feet, however, it is very hazardous.

Les Lable, representing the Montana-Dakota Utilities, stated that his groups is opposed to the concept of the bill, however, the amendments are better than the original bill.

Bob Gannon, representing the Montana Power Compnay, stated that he felt the amendments definitely help the bill.

A motion was made by Senator O'Hara that SB 290 receive a "DO PASS, as amended" recommendation from the Committee.

Senator Story stated that he agrees with Mr. Lable that the power companies will have to pay for this costly project and in order to do so the rates will probably be increased on the consumers. Perhaps the pilots should help pay for this.


Senator O'Hara withdrew his motion.

DISPOSITION OF SENATE BILL 356: This bill deals with salaries of city judges and county justices. Everyone felt the bill needed to be clearer. The amendments were discussed.

A motion was made by Senator Watt that the proposed amendments be accepted. Motion carried.

A motion was made by Senator Watt that Senate Bill 356 be given a "DO PASS, as amended" recommendation from the Committee. Motion carried.

ADJOURN: With no further business the meeting was adjourned at 2:25. The next meeting will be held on Thursday at 12:30 in Room 405 for the consideration of Senate Bills 397, 412, 417, and 505.

(2) (a) The county superintendent of schools shall receive, in addition to the salary based upon the totals of columns A and B above, the sum of \$400 per year.

(b) The county sheriff shall receive, in addition to the salary based upon the totals of columns A and B above, the sum of \$1,200 per year.

(c) Except in counties of population greater than 30,000, the county attorney shall receive, in addition to the salary based upon the totals of column A and B above, the sum of \$1,200. In each county with a population in excess of 30,000, the salary of the county attorney shall be \$30,000 per year."

Section 2. Section 7-4-2504, MCA, IS AMENDED TO READ:

"7-4-2504. Salaries to be fixed by resolution (1) The county commissioners governing body shall by resolution, on or before July 1 of each year 1979, fix the salaries of the county treasurer, county clerk, county assessor, county school superintendent, county sheriff, and county attorney, and the clerk of the district court for the following fiscal year in conformity with the appropriate statutory salary schedule pertaining to each office. The salary schedule used for each office shall be the statutory schedule in effect on the first day of the following fiscal year; however, the salary of the elected county official for fiscal year 1980 must be the greater of the amount computed by increasing the salary authorized for that official on June 30, 1979 by 7% or by

TESTIMONY RE SB 353

Having given considerable thought to the concept and implications of SB 353, it is EIC's belief that the bill will have a positive effect on planning in Montana. Particularly in unincorporated areas adjacent to the State's larger cities, there is a critical need for sound management of development patterns. It is EIC's belief that most persons currently living in such areas are anxious for the implementation of some type of land-use controls in their areas. While vocal opposition to planning and zoning can always be expected to arise in most such instances, opponents to planning are a small minority. By bringing zoning plans before the electors, citizen interest and involvement in the planning process would be enhanced. County commissioners would be provided a true measure of the planning and zoning desires of their constituencies.

While we support passage of SB 353, there are some problems with the bill which the committee should be aware of. The initial effect of the bill would likely be to motivate adoption of zoning in many unincorporated urban areas. Much of this new zoning would likely be highly restrictive-type zoning (i.e. low density - single family homes or agricultural zoning). As urban areas grow, these initial zoning classifications might become inappropriate, restricting land from being used in the most appropriate manner (i.e. commercial or industrial). The zoning amendment procedure of SB353 is cumbersome and might make zoning inflexible. Logical development patterns might be restricted from occurring as residents of an area could refuse to grant all land-use changes. A less critical consideration regarding SB 353 is who would pay for special elections required by a zoning change request - the county (i.e. the taxpayers) or the developer requesting the zoning change. Another minor question involves how an affected person would be defined in the instance of a zoning change - would this definition require a court ruling?

A technical question related to the bill involves its procedure for protesting a variance ruling by the board of adjustment. The legal function of a board of adjustment is quasi-judicial - that is, the board interprets a zoning ordinance ~~in a~~

in a manner similar to how a court might interpret a law. The Board of adjustment exists to insure the rights of individual citizens. Present law recognizes this judicial role of the Board - providing that board decisions should be appealed to the district court. The petition procedure provided for in SB 353 is not consistent with historic case law regarding the Board of Adjustment and may be subject to legal challenges.

Conclusion: I would like to reiterate our support for the concepts of SB 353. I would suggest, however, that the committee clear some of the problems which I have mentioned in this testimony.

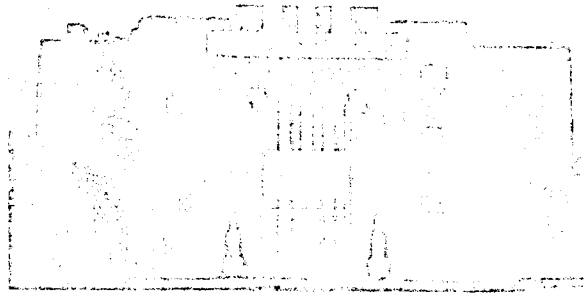

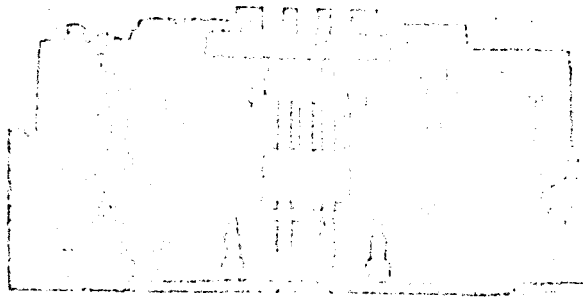

Mr. Chairman:

The Montana Sheriffs and Peace Officers Association fully appreciate the problems faced by your committee and the Legislature as a whole in setting the local elected officials' salaries. We realize the solution to the problem is very complex.

The Board of Directors of the Montana Sheriffs and Peace Officers is in favor of an amended version of Senate Bill 352. We offer this amendment to you as an aid in reaching this important, but most difficult, decision of setting the local government salaries.

The Montana Sheriffs and Peace Officers Association respectfully brings to your attention the following problems:

If the County Commissioners are allowed leeway in the various class counties in establishing salaries, this will surely cause our local government employees to join labor unions to be able to more effectively lobby the Commissioners for pay raises. This problem, I am sure, is self-evident.


If the County Commissioners are allowed to arbitrarily set salaries, they could effectively remove other elected officials from office that were in opposition to their stand on any item by holding his salary and not authorizing any reasonable pay increase.

The County Commissioners currently control the elected officials' budget, and in the Sheriff's Department, the number of Deputies allowed. If they are allowed to fix salaries, their control over elected officials would be complete.

Recently, resignations and threatened resignation from qualified personnel in the various Sheriff's departments throughout the State of Montana, have added a great deal of pressure to the Sheriff's job in providing adequate qualified law enforcement. If we are not able to offer a liveable wage to our personnel, Law Enforcement in Montana will surely deteriorate and, in the long run, cost the taxpaying citizen more for a lessor service.

I respectfully submit this for your consideration and evaluation.



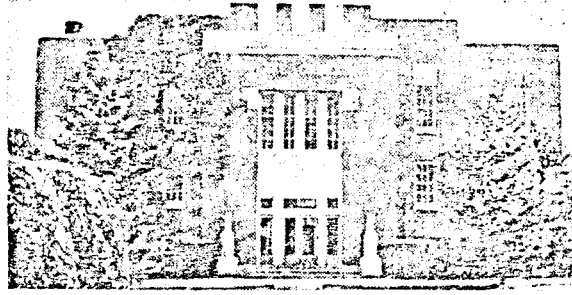


The Montana Association of Clerk and Recorders go on record in support of Senate Bill No. 352 and we wish to thank you for introducing this bill. We believe that by establishing a county compensation board as described in this bill we will be guaranteed a good and knowledgable guideline that will be acceptable by all counties and that by placing a minimum and maximum schedule it will provide a reasonable uniformity throughout the state. This provision of guidelines for the county governing body allows them to be flexible in the individual counties in a reasonable manner, and relieves them of undue pressure from special interest groups.

For budgetary protection we recommend amending line (7) page 5 to read "The governing body shall pass a resolution fixing compensation by the second Tuesday of April annually". The old law provides that a resolution be passed each year and regardless what happens to salaries this is good. That way each department knows what to budget without any guesswork.

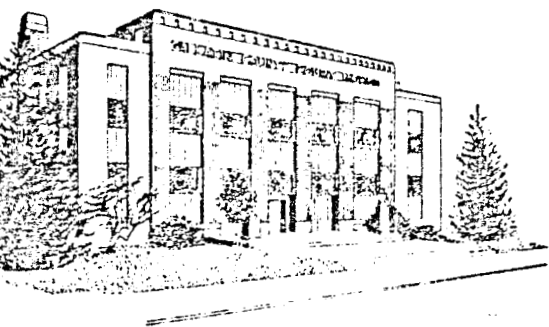

As an elected County official, I really do appreciate you and your committee's concern about our salaries. However, I do not endorse Senate Bill 352, for the reasons listed below:

(1) Section 1. A board of eleven members could be cumbersome and meeting would be costly. I question why the Clerk and Recorder is designated as one of the elected official members.

(2) Section 4. Paragraph 3 does not state that a vacancy would be filled by a person representing the same group.

(3) Section 5. The only responsibility that this bill gives to the Compensation Board, is to set minimum and maximum salaries.

(4) Section 6. This section is almost identical to the MACO supported House Bill 387, which all elected officials of the Association object to. The governing body could freeze all salaries if they fail to act on the resolution.

(5) Section 7. This section gives the governing body power to set all deputy salaries.

(6) Section 9. The present law Section 7-4-2503 is repealed. This law specifically names the Treasurer, Clerk and Recorder, Clerk of Court, Attorney, Assessor, Superintendent of Schools, Sheriff, and Surveyor. These officers should be contained within Senate Bill 352 in order that the salaries be identified with the appropriate officers. The present law Section 7-4-2505 specifies the salaries of deputies. They would lose salary protection if it is repealed.

I feel that the salary structure for the elected county officials in Montana is well over-due for a change. But I feel it's important enough for good county government, that a legislative study be made of this problem, to be presented to the next session of legislature.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. County compensation board.

(1) There is a state board of county elected officials' compensation. The board is composed of ~~14~~ 15 members who are appointed in the following manner:

(a) The governor shall appoint:

(i) three members who must be resident citizens of the general public and who do not hold any other elective or appointive public office;

(ii) three members who must be county commissioners recommended by the Montana association of counties, two of whom must be from a first-, second-, or third-class county and the other from a fourth-, fifth-, sixth-, or seventh-class county;

(iii) two members who must be elected county officials,

NEW SECTION. Section 2. Meetings of the board --

(3) The board shall elect a chairman and a

NEW SECTION. Section 4. Board term of office -- vacancies. (1) -- Members of the board shall be appointed to the following terms of office:

(1) Shall be only until the final day of the regular session of the 1981 Legislature, unless the 1981 Legislature provides that this board remain longer into service.

(a) -- The term of office for the three resident citizen members is 3 years, except for the first three members who shall serve 1-, 2-, or 3-year terms to insure overlapping terms for subsequent resident citizen members.
