

MINUTES OF THE MEETING
STATE ADMINISTRATION COMMITTEE
MONTANA STATE SENATE

February 15, 1979

The twenty-fifth meeting of the Senate State Administration Committee was called to order by Senator George Roskie, Vice Chairman, on the above date, in Room 442 of the State Capitol Building, at 10:00 a.m.

ROLL CALL: All members of the committee were present, with Sen. Story being late due to another committee meeting.

CONSIDERATION OF GOVERNOR JUDGE'S LIST OF APPOINTMENTS: Acting Chairman Roskie started with the recommendations for confirmation of the state directorships. The person assigned to do the investigating of the particular individual would be called on to make the recommendation pro or con.

Sen. Rasmussen moved the confirmation of David M. Lewis as Director of the Department of Administration; motion was unanimously passed.

Sen. Jergeson moved the confirmation of W. Gordon McOmber as Director of the Department of Agriculture; motion was unanimously passed.

Sen. Hafferman moved the confirmation of Ronald P. Richards as Director of the Department of Highways, giving background information per the resume' furnished to him. He acknowledged Richards did not have any engineering in his experience, but felt him to be a good administrator. Motion was accepted without opposition.

Sen. Brown moved confirmation of Ted J. Doney as Director of the Department of Natural Resources and Conservation. There was some discussion as to the bias of Mr. Doney and preferential treatment accorded senators or executives from ordinary citizens, but no objections to his appointment. Motion carried without opposition.

Sen. Jergeson moved confirmation of Laury Lewis as Acting Director of the Dept. of Revenue. Discussion centered on why the appointment of a temporary position should be confirmed when another person was then scheduled to take over at the end of the session. It was agreed that it was better to confirm the future appointment, rather than have a person act for almost 2 years before confirmation. Motion carried unanimously.

Sen. Ryan moved the confirmation of Mary Craig as Director of the Department of Revenue, to take effect at the end of the 1979 Legislative session; motion carried unanimously.

Sen. Jergeson moved that Keith L. Colbo be confirmed as Director of the Department of Social and Rehabilitation Services, stating that he has always done a good job in any position he held; motion carried unanimously.

Sen. Brown moved that Frank Haswell be confirmed as Chief Justice of the Montana Supreme Court, stating his background experience and qualifications; motion carried unanimously.

Sen. Hafferman moved confirmation of John Sheehy as Justice of the Montana Supreme Court and recommended him highly; motion carried unanimously.

Sen. Brown moved confirmation of James B. Wheelis as Judge of the Fourth Judicial District; motion carried without opposition.

Sen. Ryan moved confirmation of John M. McCarvel as Judge of the Eighth Judicial District and mentioned he felt he had overcome some problems and would be a good judge; motion carried unanimously.

Sen. Hafferman moved confirmation of Robert M. Holter as Judge of the Nineteenth Judicial District, stating that he was very much admired in the area by everyone. Motion passed unanimously.

After discussion as to what the functions of this board might be, such as medicare or medicaid payments from nursing homes, Sen. Jergeson moved the above persons be confirmed. Motion passed unanimously.

Chairman Story advised the Committee this report would not be sent out on the floor until after transmittal deadline. Discussion on the procedure was held with the Chairman mentioning he had received 6 letters against Ron Richards on different issues.

RECONSIDERATION OF SENATE BILL NO. 138: The Chairman explained that the Secretary of State had decided this bill was perhaps premature as they were not sure how much money they really did need. They didn't like our amendment to cut it to 10%, and rather than use this as a vehicle to transfer it to the other House, Sen. Peterson, sponsor of the bill, asked that we take it back and hold it in the committee.

Sen. Jergeson then moved that Senate Bill No. 138 be tabled; motion carried by unanimous vote.

The Committee was furnished with a copy of the Report and Recommendation of the Salary Commission which was commented on at some length, including mentioning legislators' salaries.

DISPOSITION OF SENATE BILL NO. 233: Sen. Roskie moved that Senate Bill No. 233 DO NOT PASS. Discussion was called for.

Sen. Rasmussen thought that the public did have a valid interest in this lobby measure and perhaps there would be a referendum on the issue and that it would be best to take care of it while they still had some control.

Sen. Story commented this bill focuses only on the business and industry lobbying, not on the lobbying being done by the state agencies and their personnel, which is our tax money being spent on lobbying. He felt the largest amount of money was spent by state agencies. He had gathered some statistics which indicated as much as \$1.5 million per year is spent by the Department of Natural Resources. The Department of Health also spends a great deal of money on so-called public meetings, brochures and propaganda. As an example, the Board of Health made a movie costing \$23,000 which no one will ever see - it was made to influence legislation, but failed to meet their specific purposes so it was shelved. This was paid for by our tax money.

Sen. Brown did not think the bill dealt with that and that establishment of a limitation is not good - that everyone should have to file a statement at the end of the session, whether it be a hippy-type or a Montana Power executive.

Sen. Roskie agreed with Sen. Story on the point of other groups spending large amounts of money trying to influence legislators, including the Council of Churches.

Sen. Jergeson contended it would be meaningful to the people to find out where that money was coming from.

Sen. Ryan made a correlation between this and the sudden interest in alcoholics simply because there is now a funded program dealing with them.

Question was called for. Upon roll call vote, the motion of "do not pass" carried by majority vote, with Senators Brown. Rasmussen and Jergeson voting "no".

DISPOSITION OF SENATE BILL NO. 351: The Chairman commented that the Salary Commission's Report did not show what they were particularly interested in as far as how they could relate that to this bill on increasing the Tax Appeal Board's salary, but that it should not go back to the governor because of the conflict of interest.

Sen. Jergeson moved that Senate Bill No. 351 DO PASS. Discussion ensued, with Sen. Rasmussen stating it should be amended.

Considerable discussion was held on who should handle setting the salaries for this board and the proper amount of increase to allow, after which Sen. Pat Ryan moved that Senate Bill No. 351 DO NOT PASS as a substitute motion.

Upon discussion, the Chairman explained the position had just been created a couple of sessions ago so there was really not anything comparable to use as a guide.

Upon voting, the motion failed, which brought the Committee back to the Do Pass motion.

Sen. Rasmussen made a substitute motion of DO PASS AS AMENDED and stated he would like to see the board tied to something.

Further discussion was held on the logical place to tie in this board and what increase in salary would be reasonable, with Sen. Rasmussen expressing he felt the chairman should receive at least \$1,000 more than the other board members as she also handled all of the duties that an executive secretary would do.

Researcher Kathleen Harrington explained that this board was originally under the exemption statute where the governor set the salaries and that last session, it was put under the legislature.

In discussion relating to plugging it into the state pay plan, the researcher was directed to find the grade and step which would come closest to \$21,000 for the chairman and \$20,000 for the other members. A grade 17, step 1 is presently \$20,156 and a grade 16, step 3 is \$19,341. Sen. Ryan pointed out that if this was put under the state plan, then they would get into a bunch of paperwork on having to get a job classification, etc.

In further discussion, it was mentioned trying to get away from having to consider a bill each session and changing the salary to reflect a 6% increase.

Sen. Brown moved to fix the chairman's salary at \$21,500 and the other members of the board at \$20,500 and worry about getting in another bill next time. He also included with this motion the amendment to strike any reference to the governor. The motion carried by majority vote, with Senators Hafferman and Ryan voting "no".

Sen. Brown then moved that Senate Bill No. 351 DO PASS AS AMENDED; motion carried by majority vote, with Senators Ryan and Hafferman voting "no", the amendments being as follows: (See attached copy of Standing Committee Report)

DISPOSITION OF SENATE BILL NO. 360: Sen. Jergeson felt there should be an interim study committee to study all these retirement systems as they all seem to have a rippling effect and seem to be expanding so rapidly, it is quite confusing. Sen. Roskie expressed some questions as to funding.

Sen. Roskie then moved that Senate Bill No. 360 DO NOT PASS; motion carried unanimously with Sen. Rasmussen abstaining as he did not hear the testimony on this bill.

DISPOSITION OF SENATE BILL NO. 370: Sen. Jergeson moved that Senate Bill No. 370 DO PASS on the basis of the savings to the state if private aircraft is utilized.



DISPOSITION OF SENATE BILL NO. 403: Researcher Harrington advised the Committee that none of the bills presently introduced actually recreates the board of real estate.

After discussion Sen. Bill Hafferman moved that Senate Bill No. 403 DO PASS. Sen. Jergeson made a substitute motion that Senate Bill No. 403 BE AMENDED to provide for an immediate effective date. This motion passed unanimously, as did the motion to pass, with the amendments being as follows: (See attached copy of Standing Committee Report)

There being no further business, the meeting was adjourned by Chairman Story at 12:15 P.M.
