

MINUTES OF THE MEETING
LABOR & EMPLOYMENT RELATIONS COMMITTEE
MONTANA STATE SENATE

February 17, 1979

The meeting of the Labor and Employment Relations Committee was called to order by Chairman Lowe on February 17, 1979, in Room 404 of the State Capitol at 12:30 p.m.

ROLL CALL: All members were present.

Vice-Chairman asked Senator Lowe to present Senate Bill #467 to the Committee. Senator Lowe explained that this bill would allow inspection of passenger elevators and escalators be conducted by certified inspectors of insurance companies and maintenance companies. These inspectors would be certified by the Department of Administration with reports being submitted to that Department, thus negating the necessity of the State inspecting these elevators and escalators. Senator Lowe proposed an amendment to this bill to the Committee as follows:

Page 3, lines 22 and 23.
Should not be stricken.

Senator Lowe stated that he had been informed by the Legislative Council that the striking of this line was in error and would not necessitate an amendment as it would come out correctly after the next printing. Senator Lowe proposed another amendment as follows:

Page 4, line 12.
Following: "escalators"
Insert: "in public places"

Proponents to this bill were as follows: Mr. Chad Smith, representing the Montana Hospital Association, urged the Committee to pass this bill. Mr. Smith testified that the present system caused needless costs to the consumer and to the State as elevators were also inspected by maintenance contracts, insurance companies, and OSHA. Mr. Smith cited an instance which occurred at St. Vincent's Hospital wherein an inspection was conducted which cost the hospital approximately \$600 for the inspection fee from the State, time of personnel to escort the inspector on his rounds, and inspections had already been made by the firm carrying the maintenance contract and the insurance company. Mr. Lynn Beale, representing St. Vincent's Hospital then testified regarding this incident to the Committee. Mr. Bill Leary representing the Montana Hospital Association also testified as to the needless cost to both the consumer and the State

by having the State conduct inspections of these elevators and escalators which are already inspected by other firms. Mr. Mike Young, attorney for the Department of Administration, Building Code Division presented a Statement of Intent to the Committee and urged the Committee to pass this bill. Mr. Leonard Ober, representing Shodair Hospital also testified as a proponent and his statement is attached as Exhibit "A". Rosemary Strobe, representing the Montana Chamber of Commerce, urged the Committee to pass this measure, as did Chris Johansen of the Montana Grain Elevator Association.

There were no opponents to Senate Bill #467.

Senator Dover suggested that the Committee amend page 3, lines 22 and 23 and strike out after the word "public". Senator Lowe stated that this was being taken care of in the recodification procedures so Senator Dover withdrew this amendment. Senator Dover moved the bill as amended and the Committee unanimously passed this bill.

Senator Lowe then asked the subcommittee to report their findings on Senate Bill #327. Senators Mehrens and Aklestad stated that the bill, as written, could prevent some of the young people from obtaining jobs, especially those who worked on ranches and farms, and felt that the bill was merely restricting the activities of the young. Senator Severson stated that the bill needed extensive amendments, and since the bill had reached the Committee at such a late date, it did not give the Committee ample time to research this bill and felt that the Committee should not act on it at this time. Senator Aklestad moved to table Senate Bill #327 which carried. Senator Mehrens stated that he had asked for a study of the child labor laws two years ago but had been unsuccessful in obtaining the study and suggested that the Committee could put in a resolution to obtain a study which might be successful this time.

Executive action on Senate Bill #321 was then requested by Chairman Lowe. Senator Dover moved to pass this bill, seconded by Senator Severson, which carried.

Chairman Lowe then asked the Committee to act on Senate Joint Resolution #11 - Office Building for the Department of Labor & Industry. Senator Dover felt that this bill should be passed out of Committee to the Long Range Building Committee, however, the Committee felt that it was too late for this move and discussions could be held on the floor. Senator Smith moved to pass this Resolution which carried.

The next bill to be considered for executive action was Senate Bill #252. Senator Nelson moved that the bill Do Pass, with Senator Smith moving that the bill Do Not Pass. A roll call vote was taken and the bill passed 5 to 4. Senator Smith asked the Committee for a Majority-Minority Report which is attached.

Chairman Lowe then opened the hearing on Senate Bill #378. Since Senator Peterson could not be present due to illness, Mr. Maurice Mulcahy representing the AFSCME, AFL-CIO, was asked to address the Committee. Mr. Mulcahy's statement is attached as Exhibit "B". Mr. Don Judge, representing the AFSCME, AFL-CIO also spoke in favor of the bill.

Mr. Dick Larsen, representing the City of Billings, spoke in opposition to Senate Bill #252 and Mr. Larsen's statement is attached as Exhibit "C". Mr. Jim Campbell, Personnel Director for the City of Helena also spoke in opposition to this bill and felt that police salaries should be addressed at the local level and at the negotiation tables.

After a question and answer period, the hearing on Senate Bill #252 was closed.

The hearing on Senate Bill #372 was then opened by Vice-Chairman Nelson. Senator Lowe explained that this bill would require government employers to pay the same unemployment contribution rate as a private employer thereby eliminating the special contributions plan for government employers.


Mr. Harold V. Kansier, representing the Montana Employment Security Division, then spoke in support of Senate Bill #372. Mr. Kansier presented a Fiscal Note Worksheet correction to this bill which is attached as Exhibit "D". Another proponent to this bill was Mr. Jim Campbell representing the City of Helena. Mr. Campbell stated that he felt that the cities should be accountable and responsible for their own unemployment. Rosemarie Strobe representing the Montana Chamber of Commerce, also spoke as a proponent to this bill.

There being no opponents to this bill, the hearing was closed.

Executive action was then taken on Senate Bill #372 with Senator Hafferman moving to pass the bill; Senator Dover seconded, and the motion carried.

Senate Bill #378 was then moved not to pass by Senator Dover. Senator Lowe moved to pass this bill which motion carried.

The meeting was adjourned at 2:10 p.m.

Mr. Chairman, Members of the Labor & Employment Relations Committee:

My name is Maurice Mulcahy and I appear before you today in support of Senate Bill 378 as a representative of the American Federation of State, County and Municipal Employees, AFL-CIO, and the Montana Police Protective Association.

Senate Bill 378 would raise the minimum wage for police officers in cities of the 1st and 2nd class. At the present time the minimum wage for police officers is \$750.00 per month.

In Senate Bill 378, we are asking that the minimum starting salary be raised to \$825.00 effective July 1, 1979, which is an increase of \$75.00 per month, and effective July 1, 1980, the minimum starting salary would be raised to \$900.00 per month. This would be a total increase of \$150.00 per month over a two year period.

The last time the minimum wage for police officers was increased was on July 1, 1975. To my knowledge, there is only one city in the state that starts their police officers at \$750.00 per month and keeps them at the minimum wage for a full year. I think all of the other cities have some type of a step system which allows increases within the first year.

In other words, this bill would not cost the cities much money due to the fact that most cities pay more than the minimum wage for starting officers now.

At the present time an officer receives a 1% increase in longevity pay. Senate Bill 378 does not increase this percentage, only the minimum wage.

I will give you an example of how the 1% longevity is applied: if a police officer started to work on January 1, 1977, he began receiving a \$7.50 per month longevity increment on January 1, 1978.

The longevity pay is based on 1% of the minimum wage of \$750.00 per month for each year of service up to and including the 20th year of service. Upon reaching twenty years of service, an officer would be receiving \$150.00 in longevity pay per month.

We are asking the committee to amend Senate Bill 378 on line 19 by striking the figures "20" and inserting the figures "25" and to make the same amendment on page 2, line 2, by striking "20th" and inserting "25th". What this amendment would do is allow the 1% longevity to continue up to and including the 25th year of service.

When the minimum wage law was first passed, police officers in cities of the first and second class were required to work 20 years before retiring. There was no minimum age limit for retirement. That law was changed on July 1, 1975. The law now reads that a police officer must complete 20 years of service and be 50 years of age before retirement. Almost all new police officers will work more than twenty years before retiring, which is why we are asking you to amend Senate Bill 378, to allow longevity accrual for this extended five years.

Mr. Chairman, members of the committee, I am asking your consideration of these amendments and the bill in total, and ask for a do pass recommendation.

The City of Billings is opposed to SB 378 in that we feel that this bill addresses a matter that should be handled on the local level.

Police officers of the City of Billings are represented by a bargaining unit for the purposes of collective bargaining with the City. During this collective bargaining process representatives of the bargaining unit and the City negotiate a contract which covers basically all the working conditions and compensation for police officers. The City of Billings strongly supports the collective bargaining process and feels that this is the proper method of establishing such things as the minimum wage for police officers. We feel that any outside infringement upon this process destroys the true meaning and intent of collective bargaining.

The City of Billings also opposes SB 378 because we feel that any decision made that will result in an increased cost to the local government and in turn an increased cost to local taxpayers should be made at the local level.

While the City of Billings is not opposed to an increase in the minimum wage and longevity pay of police officers, we very firmly feel that a decision of this nature should be made at the local level through the collective bargaining process. And therefore I ask that SB 378 be defeated.

Section 2 authorizes the Department to inspect all passenger elevators and escalators pursuant to applicable building codes currently in effect, and requires the establishment of uniform and reasonable fees not to exceed the expense of inspection. Section 3 requires the establishment of inspection standards to ensure compliance with the applicable state building codes. It is our intent to avoid multiplicity of inspections by the department, liability insurers, other regulatory agencies, and for elevators under maintenance contract with a bona fide maintenance company. It is further our intent that the department shall certify such inspections based upon a reasonable showing that the inspectors performing other inspections are qualified, and that the inspections themselves will achieve substantial compliance with the applicable state building codes. Finally, it is our intent that elevator inspections shall be limited to only passenger elevators and not elevators that are used primarily for the transportation of freight or cargo.


